A motion was made by **Commissioner Marshall** to approve the amendment to a **maintenance grant for the Tyler County Airport**. This grant is a 50:50 match. **Commissioner Walston** seconded the motion. All voted yes and none no.

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Walston** to table consideration of a hangar expansion and policy of the **Tyler County**

Pipeline Agreements was deferred to later in the meeting.

Commissioner Nash motioned to adopt the **Tyler County Investment Policy**, as presented by the County Treasurer. **Commissioner Marshall** seconded the motion. All voted yes and none no. SEE ATTACHED INVESTMENT POLICY

All voted yes and none no.

Larry Shepherd, engineer, presented the bids for a 400 GPM water well in Rockland for the **Tyler County Water Supply Corp.** Both bids were over \$400,000. The grant funding is for \$250,000. Mr. Shepherd stated he would make some changes to the specification. **Commissioner Marshall** motioned to reject and rebid this project, as recommended. **Commissioner Walston** seconded the motion. All voted yes and none no.

Wayne Meridith, investigator and security officer, reported to the court that an alarm system for all offices in the **courthouse and annex buildings** would cost \$19,783.60. He further recommended other means of protections for **employees** such as plexi glass and security locks. **Commissioner Marshall** indicated the county had a liability to protect its employees and motioned this item be put on the agenda as an action item. The motion was seconded by **Commissioner Hughes**. All voted yes and none no.

Mike Attaway from Garner Environmental Services and John Paul Feeley presented a need to have a contract for preplanning of hurricane and other tragedies prior to the strike of a tragedy. This would reserve generators and other emergency items to be placed and delivered by Garner Environmental Services. Judge Blanchette stated he would appoint a committee for further study: Commissioner Walston, John Paul Feely, Sheriff Wolf and himself.







BE IT REMEMBERED at a meeting of Commissioners' Court of Tyler County, Texas held on the 18th day of May, 2007 on a motion made by Martin Nash, Commissioner of Precinct No. 1, and seconded by Joe Marshall Commissioner of Precinct No. 3, the following Order was adopted:

WHEREAS, the Commissioners' Court of Tyler County, Texas, desires the establishment of prudent policies for investments; and

WHEREAS, the Commissioners' Court has reviewed the following investment policy and believes its enactment would be to the financial benefit of Tyler County, Texas;

NOW, THEREFORE, it is hereby **ADJUDGED AND DECREED** that the Tyler County Treasurer implement the following **INVESTMENT POLICY**:

OBJECTIVES AND PRIORITIES

The investment objectives of the Tyler County Treasurer shall be as follows:

*To insure the safety of Tyler County funds and to avoid

Speculative investing.

- *To keep funds available to meet the cash needs of Tyler County, Texas.
- *To earn the maximum interest rate allowed through prudent and legal investing of county funds consistent with the current Bank Depository Contract.
- *The most important priority shall be to provide for the safety of capital, securities and collateral.

INVESTMENT METHODS

The Tyler County Treasurer shall use any or all of the following types of investments consistent with federal and state law and the current Bank Depository Contract:

1. Time Deposits
2. Certificates Of Deposit
3. Security Repurchase Agreements
4. Money Market Investment Accounts
5. Negotiable Order of Withdrawal (**NOW**) Accounts
6. United States Treasury Bills
7. United State Government Securities

The County shall require delivery of all securities or shall have these securities held in the County's name by an independent third party prior to payment being made by the

County for the investment.

INVESTMENT INSTITUTIONS

The Tyler County Treasurer shall invest county funds with the following institution or groups consistent with federal and state law and the current Bank Depository Contract:

Depository Bank or other investment institution approved by the Court.

INVESTMENT COLLATERAL

The Tyler County Treasurer shall insure that invested county funds are fully collateralized consistent with federal and state law and the current Bank Depository Contract, without exception, on one or more of the following manners:

1. United States Government Bonds, Notes and Bills
2. Securities of United States Agencies
3. Federal Housing Authority Bonds
4. Farmer's Home Administration Notes
5. Federal National Mortgage Association Bonds
6. Municipal Securities bearing Moody's A or Better Rating

Such securities pledged as collateral shall be deposited in trust with the Federal Reserve Bank or an independent investment institution under an appropriate legal contract. The amount of securities so pledged shall be determined by their market value.

MATURITY AND DIVERSIFICATION

The Treasurer of Tyler County shall strive to retain enough liquidity in investments to cover the cash needs of the county and shall also strive to diversify the investments consistent with the objectives of this policy. The maximum allowable stated maturity of any individual investment owned by the County is 24 months.

LIABILITY

The County Treasurer shall not be responsible for any loss of the county funds through the failure or negligence of any depository; but nothing in this shall release any County Treasurer for any loss resulting from any official misconduct or negligence on his or her part from any responsibility for the funds of the county until a depository shall be selected and the funds deposited therein, nor for any misappropriations of such funds by her.

REPORTING

It shall be the duty of the Treasurer of Tyler County, Texas, to notify the Commissioners' Court of any significant changes in current investment methods and procedures prior to their implementation.

At least quarterly, the investment officer shall prepare and submit to the Commissioners' Court a written report of investment transactions of all county funds for the preceding

reporting period, within a reasonable time after the end of the period.




