- Dodie Construction Co.- \$ 1,346,965.00


David Waxman recommended reviewing the bids for bonds and correct figures due to a

16<sup>th</sup>. All voted and none no.

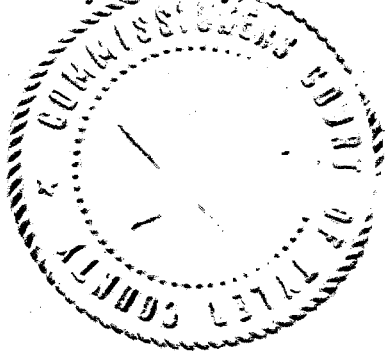
Commissioner Walston motioned the meeting adjourned. Commissioner Nash seconded
