

members of the court.

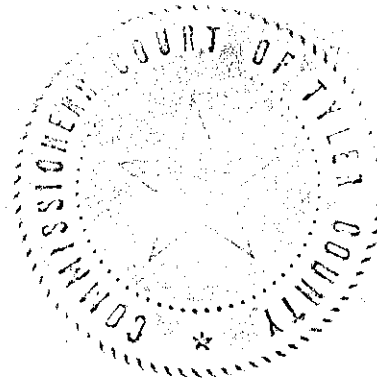
A motion was made by Commissioner Nash and seconded by Commissioner Marshall for

GUIDELINES FOR PUBLIC HEARING

In the interest of all involved and to insure that each individual is given an adequate opportunity to share his or her comments, the following guidelines will be used:

- Those who wish to express comments **must** sign in prior to the beginning of the Hearing.
- Once the Hearing begins, the moderator will recognize individuals to speak.
- Only the individual recognized by the moderator will make comments.
- Each individual will be given three minutes to express their comments.
- Communicate concerns or support as it pertains to you individually as a citizen and tax payer of this county.
- No reference by name should be made of any employee of the county.
- Individuals not following this format may be stopped from making additional comments by the moderator.

NOTE! Due to time constraints, the hearing may be recessed and reconvene at a later time.
