### Resolution Requesting Adjustments or Revisions of Rules Defining Low- and Moderate-Income & Mitigation Project Waivers

### In Tyler County and Other Hurricane Ike Disaster Counties in the DETCOG Region

WHEREAS, the Federal Government to date has allocated more than 3 billion dollars to aid in disaster recovery efforts in Texas related to Hurricanes lke and Dolly under Public Law 110-329, the Consolidated Security, Disaster Assistance, and Continuing Appropriations Act; and

WHEREAS, the State of Texas, with input from Tyler County and other local governments, has developed a Plan For Disaster Recovery, which allocates these funds in a fair and equitable manner to benefit victims throughout the affected area; and

WHEREAS, the Deep East Texas Council of Governments (DETCOG) and its member Counties, Cities, Indian Tribe, and other units of local government have played an active part in this process to ensure that the disaster recovery funding is utilized in a fair and efficient manner; and

WHEREAS, under a waiver granted by the U.S. Department of Housing and Urban Development (HUD), 50 percent of the aggregate of funds under this program must be used for support of activities producing benefit to low- and moderate-income (LMI) persons; and

WHEREAS, Tyler County supports the utilization of these funds in accordance with the LMI national objective; however, there is an inequity in the rules defining LMI which has the unintended effect of penalizing the citizens of Tyler County and other Counties with low median household incomes; and

WHEREAS, under the current rules, projects in Tyler County which would benefit persons living in households with an average annual household income of \$29,808 would not qualify under the LMI rules because they would be compared to the average household income in the County. At the same time, persons living in other Counties which are located within the Houston Metropolitan Statistical Area (MSA) would qualify under the same rules even if they had an average household income of more than \$44,000 per year, because their income would be compared to the average income of the MSA (\$44,761); and

WHEREAS, the statistics presented in Attachment A (2000 Census Bureau Data) and Attachment B (2007 Census Bureau Estimates) to this Resolution underscore the fact that all 12 of the Deep East Texas Counties are in fact low-income Counties and should be recognized as such by HUD for the purposes of this program;

WHEREAS, Tyler County is a county that has been affected by two major hurricanes, Hurricane Rita in 2005 and Hurricane Ike in 2008, both of which were devastating to the citizens and communities in this jurisdiction and the region as a whole.

WHEREAS, Tyler County is faced with a two-fold obligation. First, as an evacuation route that has been designated by the State of Texas for coastal counties in this region, this jurisdiction is tasked during the imminent threat of a hurricane to facilitate the safe and efficient evacuation of literally hundreds of thousands of Texas citizens from Jefferson, Orange, Hardin, Newton, Chambers and Harris Counties, along with many citizens of western Louisiana as they travel through Tyler County seeking shelter.

WHEREAS, Tyler County's second obligation is that upon completion of the safe evacuation of the coastal counties in the Southeast Texas region, Tyler County must also evacuate its own population in an effort to quickly get our people to safety with a much shorter response timeframe before a hurricane makes landfall.

WHEREAS, Tyler County, like its neighboring counties, must activate emergency response plans in an effort to conduct these evacuations, maintain communication and public order during the landfall of a hurricane, and initiate the sometimes nearly overwhelming tasks of search and rescue operations, damage assessments, medical support, providing for and coordinating point of distribution sites to make essential life sustaining food, supplies and services available to the population, reestablishing infrastructure, and facilitating the restoration of utility services to the general public within our jurisdiction.

WHEREAS, Tyler County must also facilitate the repatriation of not only its own population, but also the hundreds of thousands of citizens who evacuated days or weeks earlier as they proceed to their home jurisdictions.

WHEREAS, in order to conduct these essential tasks in a safe, efficient and timely manner, Tyler County has identified several mitigation projects that would enable our jurisdiction to properly serve not only the population within Tyler County, but both the entire Southeast Texas and Deep East Texas regions as a whole. These projects would enable Tyler County to provide services that are a direct benefit to every citizen in these two regions, especially those in the low to middle income categories who are often identified as being in the most need of assistance during times of disaster.

WHEREAS, after the landfall of Hurricane Katrina in New Orleans, Louisiana, in 2005, many mitigation projects were identified as being eligible and funded during the subsequent rounds of disaster relief funding to the many affected jurisdictions in that region, which provided a direct benefit to the safety and well-being of those devastated by Hurricane Katrina, and provided a means of protecting them from disaster events in the future.

WHEREAS, the completion, and subsequent maintenance and operation, of eligible mitigation projects will also provide much needed jobs, and stimulate the economy in a region that has been hard hit by the effects of the recession, and compounded by the economic devastation created by the landfall of two major hurricanes within a three-year period in the Southeast Texas and Deep East Texas area.

**NOW THEREFORE, BE IT RESOLVED,** that the Commissioners Court of Tyler County, Texas, requests the U.S. Department of Housing and Urban Development and the Texas Department of Rural Affairs to recognize the fact that Tyler County and all 12 of the Deep East Texas Counties are in fact low-income Counties and have a direct need for flexibility in determining eligible projects to include mitigation projects that allow for the preservation of life and property for the citizens of Texas, and take the following actions:

- (1) grant a waiver to correct this inequity so that the citizens of Tyler County and Deep East Texas are treated fairly and equitably; and
- (2) Amend or revise the LMI rules to allow for household income to be compared to the state average, the average for all counties within the designated disaster area, or the average income of the nearest MSA within the designated disaster area.
- (3) Amend or revise the eligible project rules to allow for jurisdictions to identify mitigation and disaster preparation projects which would allow us to better serve and provide for the future preservation of life and safety for the citizens of Tyler County, the DETCOG region and the State of Texas.

Adopted by a unanimous vote of the members present of the Commissioners Court of Tyler County on the 16<sup>th</sup> day of February, 2010.


