none no. SEE ATTACHED QUOTE.


A motion was made by Commissioner Nash and seconded by Commissioner Marshall for
the meeting to adjourn. All voted yes and none no.

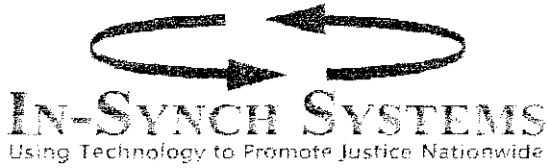

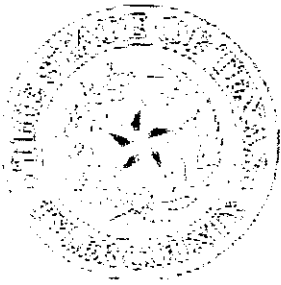
