the Commissioners' Courtroom in Woodville, Texas, the following members of the Court

The following were absent: Commissioner Nash thereby constituting a quorum. In

Rusty Hughes presented the information due to Martin Nash being absent from court. He  
stated the price of the tractor was \$ 95,115.00 to be paid by Road and Bridge Pct. 1. A  
motion was made by **Commissioner Hughes** and seconded by **Commissioner Walston**  
to approve the purchase of a **Kabota tractor** with side boom mower through HGAC. All  
present voted yes and none no.

Rusty Hughes presented the information due to Martin Nash being absent from court.  
The purchase price is \$ 39,672.26 to be paid out of Road and Bridge, Pct. 1 purchase of  
equipment line item. A motion was made by Commissioner Hughes and seconded by  
Commissioner Walston to approve the purchase **a reclaimer from Beaumont Tractor**.  
All voted yes and none no.

Judge Blanchette brought to the courts attention that the truck that Community Service  
was using was in need of repair and that the cost of the repairs really exceeded the value  
of the truck and due to the age of the truck requested this truck be approved for purchase  
for community service. He also requested that the purchase be approved out of  
contingency so as not to deplete the maintenance line item. A motion was made by  
Jacques Blanchette and seconded by Rusty Hughes to approve the purchase and be paid  
out of contingency for the **2001 Dodge extended cab truck (VIN 3B7HC13YX1G7865)**  
from Allison Chevrolet All voted yes and none no.

**Item D. To go out for bids to sell** 1997 Cheverolet 3500 four door 454 automatic  
transmission (VIN 1GCCG33J8VF00781). NO ACTION WAS TAKEN

**Item E. Contract with NEERTC to do Hazard Mitigation Action Plan Update** – Phil  
Ryan addressed the court and told them he had been unable to speak with his contact and  
therefore did not have the information needed and asked the court that no action be taken

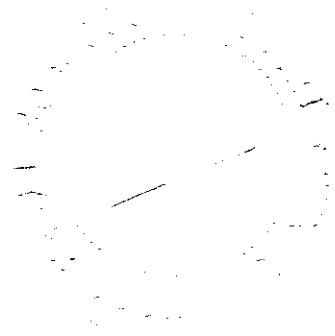
