### Per John Fuller with TAC Legal:

A BURN BAN action <u>requires</u> either an "Order Prohibiting Outdoor Burning" (to put into effect) or "Rescinding Order ..." (to take out of effect)

### All Orders relative to Outdoor Burning must:

- Be adopted in a legally posted Commissioners Court (cannot be done by or delegated to the County Judge)
- Have fire danger status documentation to back order
- Have fire danger status documentation <u>attached</u> to the Order which is filed with the County Clerk.

There is no statute or legal protocol for temporarily suspending a burn ban.




