No action was taken to re-implement the outdoor burn ban.

The County Auditor reported that she has not received all the records from the **Emergency Service Districts**. However, she has **audited the records** that she has received:

ESD7 (Colmesneil) has not been posting meeting agendas. Also, bank records show a check issued for a surgical procedure. Mrs. Skinner was told the association voted to pay on the procedure that was not fire related. However, there are no minutes or other documentation to reflect this action.

ESD1 (Ivanhoe) funds are comingled with those of the Ivanhoe volunteer fire department. Lou Cloy added this ESD received a grant for a truck from the Texas Forest Service; however, it has not been purchased.

Mrs. Skinner and Ms. Cloy both recommended the court seek technical and legal assistance from the Attorney General. Mrs. Skinner has audited as far as she can due to not being a certified public account. (Clerk's notation: Mrs. Skinner is an internal auditor hired by the county)

Executive session was not held.

Commissioner Marshall motioned and Commissioner Walston seconded the meeting to be adjourned. All voted yes and none no.
