Invocation was led by Rev. Troy Richardson, pastor of First Baptist Church, Warren. Commissioner Nash led the pledge of allegiance to the United States Flag was recited by all.

Commissioner Nash made a motion to accept the Commissioners Court minutes from the December 16th, December 28th, January 9th and January 13th meeting. **Commissioner Marshall** seconded the motion. All voted yes and none no.

Commissioner Hughes made a motion to approve the monthly reports from the Adult & Juvenile Probation Departments, County Clerk office, Extension office, Auditor's office, Treasurer's Report and Justice of the Peace, Pct. 1 office. **Commissioner Marshall** seconded the motion. All voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Walston** to approve the Allowances and Accounts Payable as presented by the Auditor's office. All voted yes and none no. SEE ATTACHED

Commissioner Walston made a motion to approve a line item transfer for **Constable, Pct. #4**. **Commissioner Marshall** seconded the motion. All voted yes and none no. SEE ATTACHED

Commissioner Marshall motioned to approve **advertisement for bids on road materials**. **Commissioner Hughes** seconded the motion. All voted yes and none no. SEE ATTACHED NOTICE TO BIDDERS

Commissioner Marshall motioned to approve **advertisement for bids on petroleum products**. **Commissioner Walston** seconded the motion. Commissioner Nash requested that U-Pump-It be added to the bid list, if they are not already on the list. All voted yes and none no. SEE ATTACHED NOTICE TO BIDDERS.

Sheriff Hennigan requested authority to pursue a grant for hardware and air cards for the computers for the **patrol cars**, along with mobile software. Also, he will request control restraints for prisoners to be funded by the grant. Sheriff Hennigan stated this would not require a match from the county. A motion was made by **Commissioner Marshall** to authorize the sheriff to seek the **CJD Grant** for law enforcement related items. The motion was seconded by **Commissioner Nash**. All voted yes and none no.

Lynette Cruse reported that Gov-Pay had a lower usage cost to the customer and will provide as many credit card swipe machines as needed. **Commissioner Walston** motioned to approve changing **credit card processing vendor** from Point and Pay to Gov-Pay, upon review and approval by the Criminal District Attorney, as recommended by the Tax Assessor/Collector. **Commissioner Hughes** seconded the motion. All voted yes and none no.

A motion was made by **Commissioner Nash** and seconded by **Commissioner Walston** to join the **Texas-21 US 287 Corridor Task Force**. The fee is to be paid from "economic development". All voted yes and none no. SEE ATTACHED

Kevin Dee with Goodwin-Lasiter reported results from a testing lab concerning problems with the **road base on Senaca Road**. He presented recommendations to fix the road. Commissioner Nash stated he would prefer seeing a detailed map showing the proposed solutions and plan, before making a decision. Judge Blanchette was concerned about other parts of the road that might break down in the future. Kevin responded there was a standard one year warranty in place in the contract. An extended warranty could be requested on the portions of the road that will be repaired. David Waxman also recommended requesting the extended warranty. Mr. Waxman also wanted a warranty from the engineer. **Commissioner Nash** made a motion to table action on this item until Friday, February 17th. **Commissioner Walston** seconded the motion. All voted yes and none no. SEE ATTACHED

Sam Haney requested use of the Tyler County Airport for an event called "**Wings and Wheels**". He presented a certificate of insurance that is a one day event policy. The Lufkin chapter has a program called "Young Eagles" where they come in and fly children ages from 8 to 18 to encourage them to get into aviation. There will also be a stunt by the Jatons (citizens of Woodville) along with car shows and motorcycle clubs. The proceeds will benefit **The Emporium for the Arts and Colmesneil School District**. Mr. Haney has been in contact with Mr. Gunn with the aviation department of the Texas Department of Transportation. The FAA requires that all funds raised at the airport stays with the airport unless it is a benefit event. He also stated that a fee is required which can not be waived and should be in the \$500 and above range. **Commissioner Marshall** motioned to accept the offer of \$600 for the required fee and approve the use of the **Tyler County Airport** for the event. The motion was made by **Commissioner Hughes**. All voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Hughes** to purchase the **hanger** from Melvon Stephenson at the **Tyler County Airport**, in the amount of \$25,000 plus closing cost. All voted yes and none no.

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Walston** to authorize Judge Blanchette to be the signatory of the **airport hanger sale**, with approval of legal counsel. All voted yes and none no.

Commissioner Walston motioned to approve a **pipeline crossing permit** on **CR 4800 (Hicksbaugh Road)** to Resaca Resources, LLC in Precinct #4. The motion was seconded by **Commissioner Marshall**. All voted yes and none no.



WHEREAS, U.S. Highway 287 is a viable alternative truck route from the Port of Port Arthur and Port of Beaumont as well as traffic from Interstate 10 to the Dallas-Fort Worth Metroplex and the Midwest United States, mitigating congestion in Harris County, Texas, improving air quality; and

WHEREAS, the Port of Beaumont is the largest military port in the United States, U.S. Highway 287 could function as a deployment route used for Strategic Defense (U.S. Highway 287 north of Fort Worth to Amarillo is designated as a Strategic Highway Network [STRAHNET]); and

WHEREAS, from 1960 to 2000 the population of the State of Texas doubled, and by 2010 almost tripled, by 2040, the population will be over 52 million; the transportation and infrastructure system of the State of Texas needs to be improved to handle the increasing population; and

WHEREAS, the Panama Canal Expansion will be completed by 2014 causing an increase in freight traffic between the ports of Texas and the various inland ports, further congesting already over-capacity highways; and

WHEREAS, within the State of Texas, U.S. Highway 287 is designated as part of the National Highway System except for an approximate 175 mile section from Corsicana to Woodville; and

Gentlemen:

The condition of the surface mix on Seneca Rd. has deteriorated rapidly over the last few months. We observed the by-products of this deterioration, which includes:

- Loss of oil-sand materials (sand, rock and asphaltic binder) to the edges of the roadway and into the ditches.
- The amount of degradation of the surfacing ranges from fairly minor to significant. In the more significant locations, there is erosion, wash-boarding and pot-holing.

We are preparing a location plan for the corrections that will be provided based on our field review. It appears that a combination of low asphalt cement content and the composition of the aggregates (sand with some clay) is the cause of the problems. The rock aggregates also vary from crushed stone to round smooth rock (pea gravel).

In summary, our firm utilized Terracon Consultants to provide coring and materials testing. The testing yielded the following results:

- Asphaltic content was low in some of the samples.
- Compacted thickness was below the required 2.5-inches on some of the samples.
- We observed small soil clods that had a clay-like consistency in the in-place surfacing.
- The requested gradation testing of the cores was not available at the time of this letter. We will report this to the County once available.

We recommend that the construction contractor (Pinto Construction) provide the following minimum corrective measures:

1. In locations where degradation is less, clean and sweep the surfaces of loose / deleterious materials and place an additional 1-inch compacted thickness of a properly prepared and constructed oil-sand mixture that performs as specified and required.



2. In locations where there is greater loss of materials, remove and dispose the entire thickness of oil-sand mixture from the Project, and replace with a minimum of 2.5-inch compacted thickness of properly prepared and constructed oil-sand mixture that performs as specified and required.

If Pinto Construction proposes an equivalent corrective action, we will report that to the County.

PLAN VIEW


