Commissioner Hughes delivered the invocation and led the pledge of allegiance to the Texas flag.

A motion was made by Commissioner Walston and seconded by Commissioner Marshall to approve the minutes of August 13th.

Chris Bottoms representing the Texas Gulf Coast Region of the American Red Cross recognized Sharon Smith for being named "Regional Red Cross Volunteer of the Year" out of a 14 county region. Judge Blanchette presented her with a certificate of appreciation.

A motion was made by Commissioner Marshall and seconded by Commissioner Nash to appoint election judges and alternate judges for a two year term, as presented by the County Clerk. All voted yes and none no. SEE ATTACHED

Judge Blanchette motioned to keep the Sheriff and Constable fees the same as last year. All voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Marshall** to approve payment of the **bills**. **Commissioner Walston** seconded the motion. All voted yes and none no. SEE ATTACHED CHECKS CLAIMS LIST

No action was taken on line item transfers/budget amendments.

A motion was made by Commissioner Walston and seconded by Commissioner Nash to approve the annual service agreement for the Kodak 140 scanners in the county clerk's office. All voted yes and none no. SEE ATTACHED

Commissioner Walston motioned to change the county payroll cycle from bimonthly (24) to a biweekly (26) pay periods annually beginning January 2013. Commissioner Marshall seconded the motion. Time sheets will be due on Tuesdays and payday will be on Thursdays, being that most holidays are on Mondays and Fridays. All voted yes and none no.

Sharon Fuller read the proposed changes to the employee policy concerning vacation accrual. Changes were to require commissioners' court approval prior to accruing excess of the maximum allowed; and, if the employee breaks service within one year the accrued vacation time will not be paid at separation. **Commissioner Nash** motioned to change

the **Employee Policy Manual** to reflect the changes concerning vacation accrual. The motion was seconded by **Commissioner Marshall**. The change will be effective September 1, 2012. All voted yes and none no. SEE ATTACHED.

Commissioner Marshall motioned to renew the current policy for 2012-2013 Texas Association of Counties Health and Employee Benefits Pool (TAC HEBP), as recommended by the County Treasurer. The new rate will be \$641.88 per employee. The motion was seconded by Commissioner Walston. All voted yes and none no. SEE ATTACHED

Judge Blanchette motioned to adopt the resolution supporting the Alabama-Coushatta Indian Tribe in the United States Court of Federal Claim's Decision, as reviewed and amended by the Criminal District Attorney. Mr. Smith explained the resolution previous submitted would have required researching the historical points presented; therefore, the resolution presented includes only the conclusion portion. The motion was seconded by Commissioner Marshall. All voted yes and none no. SEE ATTACHED RESOLUTION

Judge Blanchette explained that action taken to support gaming at the reservation, by the commissioners' court, in the past had unaware created controversy. However, it was the intention to support their right as a people to be treated equally and fairly according to the laws of the State of Texas and United States. He added that it is not a ruling of a morality type of matter, but support of laws that would apply to all. A motion was made by Judge Blanchette to adopt the resolution supporting the Alabama-Coushatta Indian Tribe in their efforts to restore fairness between the State's Indian Tribes regarding federal Indian gaming policies embodied within the Indian Gaming Regulations Act. The motion was seconded by Commissioner Walston. All voted yes and none no. SEE ATTACHED RESOLUTION

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Walston** to amend the Inter-local Cooperative Agreement with the Texas Department of Public Safety. This provides that reporting has to be done immediately when an individual is no longer disqualified from renewal of driver's license once no cause exists. All voted yes and none no. SEE ATTACHED AGREEMENT

A motion was made by **Judge Blanchette** to approve the Memorandum of Understanding for **Information Technology Services** with the **AgriLife Extension department**. **Commissioner Walston** seconded the motion. All voted yes and none no. SEE ATTACHED

A motion was made by Commissioner Nash and seconded by Commissioner Walston to approve the Articulation Agreement with the 8th Regiment of the Texas State Guard, as requested by Dale Freeman. All voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Nash** to authorize the "excess" funding to sponsor the September monthly meeting of the Deep East Texas Council of Governments (DETCOG), as done in the past. **Commissioner Marshall** seconded the motion. All voted yes and none no.

Commissioner Walston motioned to support the publishing of a public hearing regarding a waiver request under the State Medicaid Program. Commissioner Hughes seconded the motion. This is the "first step" requirement for a proposed nursing home. All voted yes and none no. SEE ATTACHED REPORT

No nominations were made to fill the vacancy of the "at large" position on the Tyler County Hospital Board. This item will be kept on the agenda until the vacancy is filled.

The executive session was not held.

To Honorable Commissioners Court:

As discussed in our Budget Workshop the following changes are to be made to our Vacation Policy effective September 1, 2012:

Waiting Period

There shall be no waiting period before an employee can use accrued vacation leave. If an employee breaks service before their 1 year anniversary date they will not be paid for any vacation accrued upon separation.

Maximum Accrual

An employee must use accrued vacation within the year or the balance will be forfeited. Unless otherwise provided for by item #2 as follows:

Luller

- 1. The maximum amount of vacation that an employee shall be allowed to have at any one time shall be the amount the employee would normally accrue in twelve (12) months if employed less than five (5) years and eighteen (18) month for five (5) years and over.
- 2. Accrual in the excess of the maximum shall be allowed only with prior approval by Commissioners Court.
- 3. An employee who has been allowed to accrue vacation in the excess of the maximum shall promptly take vacation to reduce the balance to or below the maximum as soon as circumstances and needs in the county allow it.



Hi Judge -

I regret not being in the office when you contacted us about alternates. Your plan received 1/10 percent renewal increase which is excellent. In turn, Tyler County will be receiving \$44,463 in surplus distribution. I am assuming the request for alternates is based on budgetary needs, however, if that is not the case your group is in a very good position staying with the current plan.

The attached doc. has 2 options for you to consider. The first is the Grandfathered version of your current plan. It is an excellent choice that will save money, but continue to work in the same manner that your current benefits do with slight changes. The 2nd option is for a Non-Grandfathered plan where preventive care will no longer have a co-pay attached. As you can see it costs a bit more money. That is due to the increased responsibility on your plan to cover the costs of preventive care. We have one more year that plans can keep their grandfathered status according to health care reforms. We would recommend retaining that status, as you cannot go back to it, and there will be many changes coming soon in all probability.

ARTICULATION AGREEMENT

between the 8th Regiment of the Texas State Guard and the County of Tyler

The following is an articulation agreement between the 8th Regiment of the Texas State Guard and the County of Tyler.

This agreement is beneficial to the Texas State Guard to address the need to have the 3rd Battalion of the 8th Regiment retain its headquarters in its area of operation, including Tyler County. Likewise this agreement is beneficial to Tyler County in that the presence of the 3rd Battalion of the Texas State Guard headquarters in the institutions desire to further expand its image in the local community in a positive aspect.

Tyler County is willing to provide the use of the Nutrition Center at 201 Veterans Way, Woodville, Texas 75979 to the 3rd Battalion to hold its monthly drills. This would be a turn-key operation in which the Texas State Guard would guarantee that the facilities would be left in the same condition as when they took possession of the facility.

These drills are usually on the 3rd weekend of the month with soldiers reporting for duty approximately 1800 hours (6:00 pm) on Friday and departing no later than 1800 hours (6:00 pm) Sunday. Keys will be provided to a representative of the Texas State Guard 3rd/8th. The representative of the Texas State Guard will coordinate with the County Emergency management Coordinator no later than a week before an upcoming drill. For 2013, facilities will be utilized in Jan, Feb, Mar, Apr, May, July, and Aug at the maximum.

The Texas State Guard is willing to adjust the normally scheduled drill date to meet the need for the County to utilize the facility.

Either organization has full rights to terminate this agreement at will with no legal recourse.

Interlocal Cooperation Contract

I. Parties

II. Overview

The purpose of this Contract is to implement the provisions of Texas Transportation Code Chapter 706. A local political subdivision may contract with the TDPS to provide information necessary to deny renewal of the driver license of a person who fails to appear for a complaint or citation or fails to pay or satisfy a judgment ordering payment of a fine and cost in the manner ordered by the court in a matter involving any offense that a court has jurisdiction of under Chapter 4, Code of Criminal Procedure.

The TDPS has authority to contract with a private vendor ("Vendor") pursuant to Texas Transportation Code §706.008. The Vendor will provide the necessary goods and services to establish an automated system ("FTA System") whereby information regarding violators subject to the provisions of Texas Transportation Code Chapter 706 may be accurately stored and accessed by the TDPS. Utilizing the FTA System as a source of information, the TDPS may deny renewal of a driver license to a person who is the subject of an FTA System entry.

Each local political subdivision contracting with the TDPS will pay monies to the Vendor based on a fee established by this Contract. The TDPS will make no direct or indirect payments to the Vendor. The Vendor will ensure that accurate information is available to the TDPS, political subdivisions and persons seeking to clear their licenses at all reasonable times.

III. Definitions

"Complaint" means notice of an offense as defined in Article 27.14(d) or Article 45.019, Code of Criminal Procedure.

"Department" or "TDPS" means the Texas Department of Public Safety.

"Failure to Appear Program" or "FTA Program" refers to the implementation efforts of all parties, including those system components provided by the TDPS, local political subdivisions and the Vendor, including the FTA System.

"Failure to Appear System" or "FTA System" refers to the goods and services, including all hardware, software, consulting services, telephone and related support services, supplied by the Vendor.

"FTA Software" refers to computer software developed or maintained now or in the future by the Vendor to support the FTA System.

"Originating Court" refers to the court in which an applicable violation has been filed for which a person has failed to appear or failed to pay or satisfy a judgment and which has submitted an appropriate FTA Report.

"State" refers to the State of Texas.

"Local political subdivision" refers to a city or county of the State of Texas.

Unless otherwise defined, terms used herein shall have the meaning assigned by Texas Transportation Code Chapter 706 or other relevant statute. Terms not defined in this Contract or by other relevant statutes shall be given their ordinary meanings.

IV. Governing Law

This Contract is entered into pursuant to Texas Government Code Chapter 791 and is subject to the laws and jurisdiction of the State of Texas and shall be construed and interpreted accordingly.

V. Venue

The parties agree that this Contract is deemed performable in Travis County, Texas, and that venue for any suit arising from the interpretation or enforcement of this Contract shall lie in Travis County, Texas.

VI. Application and Scope of Contract

This Contract applies to each FTA Report submitted to and accepted by the TDPS or the Vendor by the local political subdivision pursuant to the authority of Texas Transportation Code Chapter 706.

VII. Required Warning on Citation for Traffic Law Violations

A peace officer authorized to issue citations within the jurisdiction of the local political subdivision shall issue a written warning to each person to whom the officer issues a citation for a traffic law violation. This warning shall be provided in addition to any other warnings required by law. The warning must state in substance that if the person fails to appear in court for the prosecution of the offense or if the person fails to pay or satisfy a judgment ordering the payment of a fine and cost in the manner ordered by the court, the person may be denied renewal of the person's driver license. The written warning may be printed on the citation or on a separate instrument.

VIII. FTA Report

If the person fails to appear or fails to pay or satisfy a judgment as required by law, the local political subdivision may submit an FTA Report containing the following information:

- (1) the jurisdiction in which the alleged offense occurred;
- (2) the name of the local political subdivision submitting the report;
- (3) the name, date of birth and Texas driver license number of the person who failed to appear or failed to pay or satisfy a judgment;
- (4) the date of the alleged violation;
- (5) a brief description of the alleged violation;
- (6) a statement that the person failed to appear or failed to pay or satisfy a judgment as required by law;
- (7) the date that the person failed to appear or failed to pay or satisfy a judgment; and
- (8) any other information required by the TDPS.

There is no requirement that a criminal warrant be issued in response to the person's failure to appear. The local political subdivision must make reasonable efforts to ensure that all FTA Reports are accurate, complete and non-duplicative.

IX. Clearance Reports

The originating court that files the FTA Report has a continuing obligation to review the report and promptly submit appropriate additional information or reports to the Vendor or the TDPS. The clearance report shall identify the person, state whether or not a fee was required, advise the TDPS to lift the denial of renewal and state the grounds for the action. All clearance reports must be submitted immediately from the time and date that the originating court receives appropriate payment or other information that satisfies the citizen's obligation to that court.

To the extent that a local political subdivision utilizes the FTA Program by submitting an FTA Report, there is a corresponding obligation to collect the statutorily required \$30.00 administrative fee. If the person is acquitted of the underlying offense for which the original FTA Report was filed, the originating court shall not require payment of the administrative fee. The local political subdivision shall submit a clearance report immediately advising the TDPS to lift the denial of renewal and identifying the grounds for the action.

The local political subdivision must immediately file a clearance report upon payment of the administrative fee and:

- (1) the perfection of an appeal of the case for which the warrant of arrest was issued or judgment arose;
- (2) the dismissal of the charge for which the warrant of arrest was issued or judgment arose;
- (3) the posting of a bond or the giving of other security to reinstate the charge for which the warrant was issued;
- (4) the payment or discharge of the fine and cost owed on an outstanding judgment of the court; or
- (5) other suitable arrangement to pay the fine and cost within the court's discretion.

The TDPS will not continue to deny renewal of the person's driver license after receiving notice from the local political subdivision that the FTA Report was submitted in error or has been destroyed in accordance with the local political subdivision's record retention policy.

X. Compliance with Law

The local political subdivision understands and agrees that it will comply with all local, state and federal laws in the performance of this Contract, including administrative rules adopted by the TDPS.

XI. Accounting Procedures

An officer collecting fees pursuant to Texas Transportation Code §706.006 shall keep separate records of the funds and shall deposit the funds in the appropriate municipal or county treasury. The custodian of the municipal or county treasury may deposit such fees in an interest-bearing account and retain the interest earned thereon for the local political subdivision. The custodian shall keep accurate and complete records of funds received and disbursed in accordance with this Contract and the governing statutes.

The custodian shall remit \$20.00 of each fee collected pursuant to Texas Transportation Code \$706.006 to the Comptroller on or before the last day of each

calendar quarter and retain \$10.00 of each fee for payment to the Vendor and credit to the general fund of the municipal or county treasury.

XII. Payments to Vendor

The TDPS has contracted with OmniBase Services of Texas ("Vendor"), a corporation organized and incorporated under the laws of the State of Texas, with its principal place of business in Austin, Texas, to assist with the implementation of the FTA Program.

The local political subdivision must pay the Vendor a fee of \$6.00 per person for each violation which has been reported to the Vendor and for which the local political subdivision has subsequently collected the statutorily required \$30.00 administrative fee. In the event that the person has been acquitted of the underlying charge, no payment will be made to the Vendor or required of the local political subdivision.

The parties agree that payment shall be made by the local political subdivision to the Vendor no later than the last day of the month following the close of the calendar quarter in which the payment was received by the local political subdivision.

XIII. Litigation and Indemnity

In the event that the local political subdivision is aware of litigation in which this Contract or Texas Transportation Code Chapter 706 is subject to constitutional, statutory, or common-law challenge, or is struck down by judicial decision, the local political subdivision shall make a good faith effort to notify the TDPS immediately.

Each party may participate in the defense of a claim or suit affecting the FTA Program, but no costs or expenses shall be incurred for any party by the other party without written consent.

To the extent authorized by law, the local political subdivision dity agrees to indemnify and hold harmless the TDPS against any claims, suits, actions,

damages and costs of every nature or description arising out of or resulting from the performance of this Contract, and the local political subdivision City further agrees to satisfy any final judgment awarded against the local political subdivision City or the TDPS arising from the performance of this Contract, provided said claim, suit, action, damage, judgment or related cost is not attributed by the judgment of a court of competent jurisdiction to the sole negligence of the TDPS.

It is the agreement of the parties that any litigation involving the parties to this Contract may not be compromised or settled without the express consent of the TDPS, unless such litigation does not name the TDPS as a party.

This section is subject to the statutory rights and duties of the Attorney General for the State of Texas.

XIV. Contract Modification

No modifications, amendments or supplements to, or waivers of, any provision of this Contract shall be valid unless made in writing and executed in the same manner as this Contract.

XV. Severability

If any provision of this Contract is held to be illegal, invalid or unenforceable under present or future laws effective during the term hereof, such provision shall be fully severable. This Contract shall be construed and enforced as if such illegal, invalid or unenforceable provision had never comprised a part hereof, and the remaining provisions shall remain in full force and effect and shall not be affected by the illegal, invalid or unenforceable provision or by its severance therefrom.

XVI. Multiple Counterparts

This Contract may be executed in a number of identical counterparts, each of which shall be deemed an original for all purposes and all of which constitutes, collectively, one Contract. But, in making proof of this Contract, it shall not be necessary to produce or account for more than one such counterpart.

XVII. Effective Date of Contract

This Contract shall be in effect from and after the date that the final signature is set forth below. This Contract shall automatically renew on a yearly basis. However, either party may terminate this Contract upon thirty days written notice to the other party. Notice may be given at the following addresses:

Memorandum of Understanding for Information Technology Services

Tyler County

The purpose of this Memorandum is to clarify responsibilities of the Texas AgriLife Extension (AL-EXT) and Tyler County regarding Information Technology support for the Tyler County AgriLife Extension Service office. This understanding is not a contract and can be modified at any time during the coverage period with agreement from both parties.

The term of this Memorandum of Understanding is two years beginning on <u>September 1, 2012</u> and continuing through **August 31, 2014**.

The following Information Technology components are to be managed per this understanding:

FEES

Due to the Cooperative agreements between Texas county governments and Texas AgriLife Extension a fee for services by either party is not required.

FACILITY

The County will ensure facilities provided to and occupied by the AgriLife Extension Office are equipped with data communications wiring that adhere to Tyler County Information Technology standards.

TELEPHONES

The County owns, manages, and maintains all standard telephony and Voice over Internet Protocol Telephony Devices assigned to the Tyler County AgriLife Extension Office.

ACCESS

Logical - Network and Internet Access

Tyler County provides the AgriLife Extension Office with full Internet Access. This access includes Electronic mail service to the AL-EXT provided email service. In addition, agents and staff in the AgriLife Extension Office may also have Tyler County email service if needed. AL-EXT understands that Internet Access is in accordance with Tyler County operations standards.

Cost associated with Internet Service

Tyler County provides Internet Service at no additional cost to AL-EXT

COMPUTER HARDWARE (includes printers, scanners, projectors)

Initial Purchase and Configuration:

Tyler County will provide computer systems to the AgriLife Extension Office including initial setup and delivery. Computers will include configurations and standard software listed as described under "Standard Software Requirements. These computers will meet both AL-EXT and Tyler County security configuration standards.

Special Configuration Items

Administrative level accounts will be maintained on all computer systems to allow either Tyler County or AL-EXT to troubleshoot problems.

General Hardware Support:

Tyler County will facilitate trouble-shooting computer hardware and peripheral devices and take corrective actions in accordance with Tyler County operation standards. Tyler County IT unit will contact AgriLife Information Technology as needed to ensure AL-EXT operation standards are met. AgriLife Extension Office staff will contact the Tyler County IT help desk per county operation standards

The following is an articulation agreement between the 8th Regiment of the Texas State Guard and the County of Tyler.

This agreement is beneficial to the Texas State Guard to address the need to have the 3rd Battalion of the 8th Regiment retain its headquarters in its area of operation, including Tyler County. Likewise this agreement is beneficial to Tyler County in that the presence of the 3rd Battalion of the Texas State Guard headquarters in the institutions desire to further expand its image in the local community in a positive aspect.

Tyler County is willing to provide the use of the Nutrition Center at 201 Veterans Way, Woodville, Texas 75979 to the 3rd Battalion to hold its monthly drills. This would be a turn-key operation in which the Texas State Guard would guarantee that the facilities would be left in the same condition as when they took possession of the facility.

These drills are usually on the 3rd weekend of the month with soldiers reporting for duty approximately 1800 hours (6:00 pm) on Friday and departing no later than 1800 hours (6:00 pm) Sunday. Keys will be provided to a representative of the Texas State Guard 3rd/8th. The representative of the Texas State Guard will coordinate with the County Emergency management Coordinator no later than a week before an upcoming drill. For 2013, facilities will be utilized in Jan, Feb, Mar, Apr, May, July, and Aug at the maximum.

The Texas State Guard is willing to adjust the normally scheduled drill date to meet the need to the County to utilize the facility.

o the quality of existing nursing facility services under the state Medicaid program
in the county;
 the quality of the proposals submitted; and
o the degree of community support for additional nursing facility services
If the Court decides to proceed with the waiver request, the Commissioners Court sends a
letter to DADS requesting that DADS issue a waiver to a person or entity who submitted
a proposal to build the new nursing home. (There are requirements as to information to be
included in the letter.)
DADS will respond with a letter issuing the Medicaid beds to the recommended entity or
person. (Note: Statewide, only 500 beds are added annually. If the allotment is already
filled for the current year, the request will automatically be carried to the following year.)
