Commissioner Hughes explained that some people don't want to rent the entire facility at
the rodeo arena so he recommended a fee for partial use of the facility. Also, he reported
that the lights are being left on at times without his knowledge of the arena being used.

A motion was made by Commissioner Hughes to change the policy for using the rodeo
arena facility: the rental fee of an "outbuilding" only will be \$100.00; the rental of the
rodeo arena will remain at \$200.00; and, permission to use any part of the facility must be
approved by the commissioner that oversees the rodeo arena facility or commissioners'
court. The motion was seconded by Commissioner Marshall. All voted yes and none no.


A motion was made by Commissioner Hughes to adjourn. Commissioner Marshall
seconded the motion. All voted yes.

RULES CONCERNING USE
OF THE TYLER COUNTY 4-H & FFA RODEO ARENA COMPLEX
ADOPTED 1-15-92
AMENDED 7-12-96
AMENDED 5 16-03

Submitted by Tyler County Commissioner Precinct II, Tyler County Extension Agent-Agriculture
Tyler County Vocational Agriculture Teachers

1. No events will be approved which conflict with, or the interest of, the three traditional events held at the complex, ie: The Dogwood Festival & Western Weekend and the Tyler County Fair. A resident or residents of Tyler County must sponsor all groups using the facility.
2. There will be no charge for 4-H and FFA events held, plus any youth activity with the activity consisting of youth enrolled in schools that the board considers acceptable, however, donations may be made and should be considered.
3. Officers and employees of Tyler County, The Tyler County Commissioners Court, Texas Agricultural Extension Service, County Agents and /or Vocational Agriculture Teachers assume no responsibility and will not be held liable for accidents and/or damage incurred by people animals showing in or visiting the arena complex. The group using the facility (other than those listed in item two (2) above) will be responsible for liability insurance for the event and must provide proof of acceptable liability insurance in an amount of \$50,000 for each person and \$100,000 for each accident that occurs during that event. The group using the facility will be responsible for insurance of the event and must provide proof to the Tyler County Extension Agent or Tyler County Commissioner Precinct II.
4. Arena use fees are:
 - A. All day or lighted event \$200.00/per day
 - B. All funds generated by arena use will be used for upkeep and expansion of the facilities. Any and all extra donations will be used for these purposes.
 - C. All fees will be collected in advance by person in charge of event such as,
Tyler County Dogwood Director
Tyler County Fair Director
 - D. There will be a \$20.00 charge for all booths and camping spaces including trailer hook-ups.
5. Tyler County Commissioner II and Tyler County Extension Agent will keep an arena calendar and there will be a 30 day deadline on getting on the calendar.
6. Persons or organizations wishing to use arena will check with Extension Agent or Tyler County Commissioner II about transporting stock from the pound pens.
7. Enforcement of rules rest with the Tyler County Extension Agent, the Tyler county Vocational Agriculture Teachers, and the Tyler County Commissioners County.
8. No Livestock stored or kept without the consent of Tyler County Extension Agent and/or Tyler County Commissioner II.
