Executive session was not held.


A motion was made by Commissioner Nash and seconded by Commissioner Marshall for
the meeting to adjourn. All voted yes and none no.

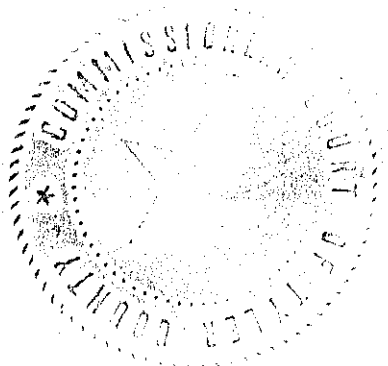

The Tyler County Commissioners Court will hold two public hearings on a proposal to increase total tax revenues from properties on the tax roll in the preceding tax year by 10% General Fund (percentage by which proposed tax rate exceeds lower of rollback tax rate or effective tax rate calculated under Chapter 26, Tax Code). Your individual taxes may increase at a greater or lesser rate, or even decrease, depending on the change in the taxable value of your property in relation to the change in taxable value of all other property and the tax rate that is adopted.

The first public hearing will be held on SEPTEMBER 24, 2013 at 8:30 A.M. in the Commissioners Courtroom.

The second public hearing will be held on SEPTEMBER 27, 2013 at 8:30 A.M. in the Commissioners Courtroom.

The members of the governing body voted on the proposal to consider the tax increase as follows:

The average taxable value of a residence homestead in Tyler County last year was \$46,756 for General Fund. Based on last year's tax rate \$.45804 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$214.16.

The average taxable value of a residence homestead in Tyler County this year is \$47,279 for General Fund. If the governing body adopts the effective tax rate for this year of \$.49652 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$234.75

If the governing body adopts the proposed tax rate of \$.54619 per \$100 of taxable value for General Fund, the amount of taxes imposed this year on the average home would be \$258.23

Citizens of Tyler County are welcome to attend and participate in this important public hearing.
