A report was accepted from the Tax Assessor/Collector about continuing education activities for 2014.

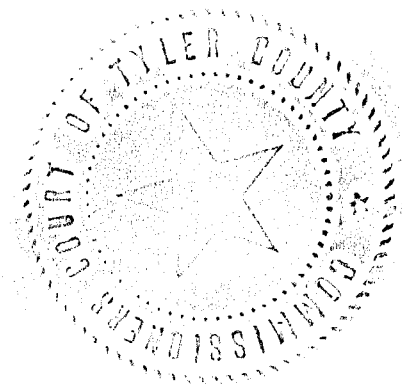
A motion was made by Commissioner Martin Nash and seconded by Commissioner Mike Marshall that the meeting adjourn. All voted yes and none no.

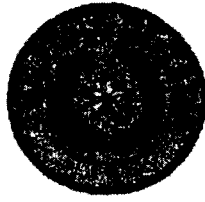
