ADOPTED this the 26th day of October by a vote of 4 ayes and 0 nay.

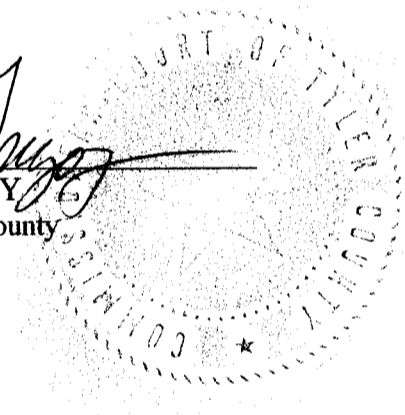
