

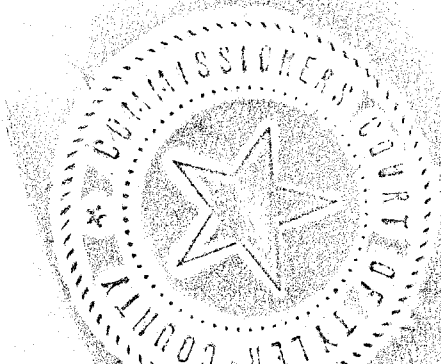
A motion was made by Commissioner Marshall and seconded by Commissioner Walston that the meeting adjourn. All voted yes.
