After calling the meeting to order, Judge Blanchette invited anyone offended by the customary prayer to step out in the hall and return after the conclusion of the prayer. The invocation was delivered by Donece Gregory, County Clerk. The Pledge of Allegiance to the American Flag was delivered by Commissioner Walston.

Representatives from the Child Welfare Board, Juvenile Probation, Child Protective Services, and CASA, agencies for children, were present in support of the proclamation for Child Abuse Prevention Month. A motion was made by Commissioner Marshall and seconded by Commissioner Nash to proclaim April 2018 as Child Abuse Prevention Month in Tyler County. All voted yes and none no. SEE ATTACHED PROCLAMATION

Commissioner Marshall motioned to receive the minutes of March 12th, 14th and 28, 2018. Commissioner Nash seconded the motion. All voted yes and none no.

Commissioner Hughes made a motion to approve the monthly reports from the Adult & Juvenile Probation Departments, County Clerk, District Clerk, County Treasurer, County Auditor, County Extension and Justice of the Peace, Pct. 1. Commissioner Marshall seconded the motion. All voted yes and none no. SEE ATTACHED

A motion was made by Commissioner Walston and seconded by Commissioner Marshall to approve the allowances and accounts payable. All voted yes and none no. SEE ATTACHED

Budget amendments/line item transfers were not presented by the County Auditor.

Judge Blanchette motioned to ratify the county payroll for March 14-27, 2018, as presented by the County Auditor. The motion was seconded by Commissioner Marshall. All voted yes and none no. SEE ATTACHED

Commissioner Marshall motioned to approve the county payroll for March 28-April 10, 2018, as presented by the County Auditor. The motion was seconded by Commissioner Walston. All voted yes and none no. SEE ATTACHED

A motion was made by Commissioner Marshall and seconded by Commissioner Hughes to appoint Trisher Ford to the Tyler County Child Welfare Board. All voted yes and none no.

Stevan Sturrock, Rachel Iglesias and Crystal Petri presented the fundraising efforts of Leadership Southeast Texas and Youth Leadership Southeast Texas. Puncture resistant safety gloves were purchased for the Tyler County Sheriff's office, Hardin County Sheriff's office and police departments in both counties. The gloves cost \$50 each. A motion was made by Commissioner Nash and seconded by Commissioner Marshall to accept the gift of the security gloves for the sheriff's department. All voted yes and none no.

A motion was made Commissioner Marshall and seconded by Commissioner Walston to adopt the resolution for "Prisoners of the State". This resolution is requesting the state reimburse counties for housing prisoners, while in county custody, awaiting transport or violation of parole. All voted yes and none no. SEE ATTACHED RESOLUTION

A motion was made Commissioner Marshall and seconded by Commissioner Nash to adopt the resolution for "Local Decisions" concerning additional revenue and appraisal caps required by the State of Texas. Commissioner Nash added that if additional caps were imposed, the county would have to cut services. All voted yes and none no. SEE ATTACHED RESOLUTION

A motion was made Commissioner Marshall and seconded by Judge Blanchette to adopt the resolution for Indigent Defense, stating that the State of Texas should fully fund the cost of Indigent Criminal Defense instead of being a tax burden on the local tax payers. All voted yes and none no. SEE ATTACHED RESOLUTION

A motion was made Commissioner Marshall and seconded by Commissioner Walston to adopt the resolution against "unfunded mandates". This resolution requests a Constitutional Amendment to prohibit the imposition of state mandated government programs on local governments without being fully funded by the State of Texas. All voted yes and none no. SEE ATTACHED RESOLUTION

A motion was made Commissioner Marshall and seconded by Commissioner Nash to adopt the resolution encouraging the State of Texas to renew its commitment to school funding, relieving the burden on the local tax payers. All voted yes and none no. SEE ATTACHED RESOLUTION

A motion was made by Judge Blanchette to adopt the resolution to seek a Hazard Mitigation Planning Grant, as presented by Ken Jobe. The motion was seconded by Commissioner Marshall. All voted yes and none no. SEE ATTACHED RESOLUTION

Commissioner Nash motioned to approve the Memorandum of Understanding with the Texas Attorney General. The County Auditor explained the OAG wanted secure internet along with a secure physical place for a computer. Commissioner Hughes seconded the motion. All voted yes and none no. SEE ATTACHED MEMORANDUM

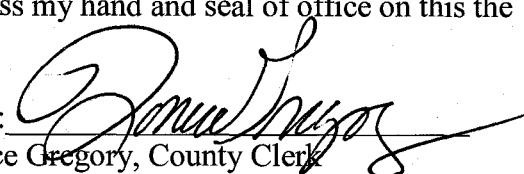
Executive Session was not held.

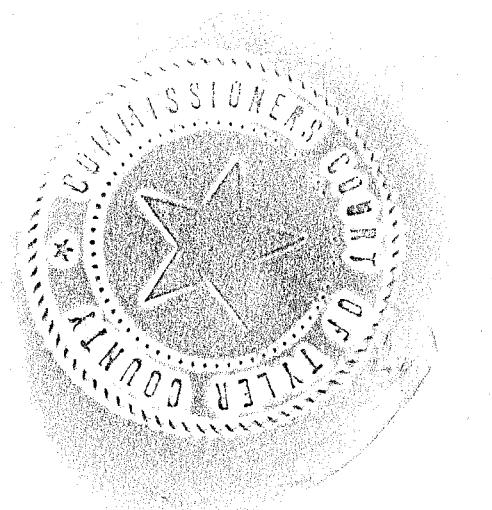
A motion was made by Commissioner Nash and seconded by Commissioner Marshall that the meeting adjourn. All voted yes.

2018 PROCLAMATION DECLARING APRIL AS CHILD ABUSE PREVENTION MONTH

WHEREAS, There were **298,732 reported cases** of child abuse and neglect last year in Texas; and

WHEREAS, There were **172 child deaths** as a result of child abuse and neglect last year in Texas; and

WHEREAS, There were **327 children** in Tyler County that were reported as abused or neglected last year; and

WHEREAS, There were **176 investigations** of child abuse and neglect last year in Tyler County; and

WHEREAS, There were **18 investigations** of child abuse or neglect opened for services last year in Tyler County; and

WHEREAS, Child abuse and neglect is a community problem affecting the current and future quality of life of a community; and

WHEREAS, Child abuse prevention is a community responsibility and finding solutions depends upon involvement among all people; and

WHEREAS, Communities must make every effort to promote programs that benefit children and their families; and

WHEREAS, Effective child abuse prevention programs succeed because of partnerships among agencies, schools, religious organizations, law enforcement agencies, and the business community; and

WHEREAS, Everyone in the community should become more aware of child abuse prevention and all citizens should become more involved in supporting families to provide safe, nurturing environments for their children, giving them the opportunity to grow up to be caring, contributing members of the community;

NOW, THEREFORE, I, County Judge Jacques L. Blanchette of Tyler County, Texas, by virtue of the authority vested in me, do hereby proclaim the month of April 2018 to be **CHILD ABUSE PREVENTION MONTH** in Tyler County. I also proclaim that Sunday, April 29, 2018 to be "Blue Sunday" and in so doing, urge all citizens to join in a national effort to raise awareness about the importance of preventing child abuse and showing support by wearing blue in support of the prevention of child abuse and neglect.

Unfunded Mandates

WHEREAS, the Texas counties are responsible for the operation and management of many and various governmental programs as required or authorized by state law; and

WHEREAS, some county government programs are fully or partially supported with funds disbursed by the State of Texas pursuant to the state appropriations process; and

WHEREAS, the State of Texas, acting through the Texas Legislature or through a state agency or executive order, may enact laws or promulgate rules that have the effect of imposing mandatory financial obligations upon Texas counties; and

WHEREAS, the State of Texas, acting through the Texas Legislature or through a state agency or executive order, mandates that counties implement certain governmental programs or perform certain duties and obligations including financial commitments by a county to expend county funds in connection therewith; and

WHEREAS, during each regular session of the Texas Legislature, all state funds that support county programs are reviewed through the state appropriation process and by other budgetary review systems; and

WHEREAS, the aforementioned review process may result in a reduction, or cessation, of state financial support of county government programs causing an unforeseeable disruption and reduction of the county budget and operations; and

WHEREAS, Texas counties cannot achieve reliable financial planning and the necessary bond ratings sufficient to support county-related obligations when the state mandates a new program that is not fully funded or under conditions where the state reduces or fully withdraws prior funding and disbursement for county government programs;

NOW THEREFORE, BE IT RESOLVED. this the 11th day of April, 2018 by the Tyler County Commissioners Court that it is in the best interests of local governments and their taxpayers to support and favor the passage of legislation in the form of an amendment to the Constitution of the State of Texas that would expressly prohibit the imposition of a mandatory governmental program on Texas local governments, whether by an act of the Texas Legislature or a state agency or by executive order, unless the State of Texas has fully funded and disbursed all necessary funds to enable local governments to operate said governmental program.

**MEMORANDUM OF UNDERSTANDING BETWEEN
THE OFFICE OF THE ATTORNEY GENERAL

Agreement Number 18-C0108

The Memorandum of Understanding (the Agreement) is entered into by and between the Office of the Attorney General of Texas (the OAG) and Tyler County (the County) in compliance with the provisions of Texas Government Code §771 and Texas Family Code §231.002. In this Agreement, the OAG and the County are referred to individually as a "Party" and collectively as the "Parties."

1. PURPOSE AND STATEMENT OF SERVICES

In support of the OAG's duties as a Title IV-D agency, the County agrees to provide a physical location within the County Facility, located at 100 West Bluff, Woodville, TX 75979, for the OAG to install equipment necessary to establish a secure wireless internet connection. The County and the OAG will cooperate to identify a secure physical location within the County Facility that will at all times protect the OAG equipment against any unauthorized access. The County agrees to allow the OAG access to the County Facility and the OAG Equipment during the days and times the County Facility is normally open.

The OAG is solely responsible for installation, maintenance, and repair of OAG equipment installed at the County Facility. The OAG agrees to perform all installation, repair, and maintenance to OAG equipment during the days and times the County Facility is normally open.

2. TERM

This Agreement is effective on April 11, 2018 and shall continue until terminated as provided herein.

3. FINANCIAL MATTERS

The Parties are responsible for their respective costs associated with performance under this Agreement.

4. NOTICES

Any notice required or permitted to be given under this Agreement by one Party to the other Party shall be in writing and shall be addressed to the receiving Party at the address hereinafter specified. The notice shall be deemed to have been given immediately if delivered in person to the recipient's address hereinafter specified. It shall be deemed to have been given on the date of certified receipt if placed in the United States Mail, postage prepaid, by registered or certified mail with return receipt requested, addressed to the receiving Party at the address hereinafter specified.

8. TERMINATION

Either Party may terminate this Agreement, in whole or in part, without penalty, by providing thirty (30) calendar days advance written notice to the other Party.

If Federal or State laws or regulations or other Federal or State requirements are amended or judicially interpreted so that either Party cannot reasonably fulfill this Agreement and if the Parties cannot agree to an amendment that would enable substantial continuation of this Agreement, the Parties shall be discharged from any further obligations under this Agreement.

Termination of this Agreement for any reason shall not release either Party from any liability or obligation set forth in this Agreement that is expressly stated to survive any such termination or by its nature would be intended to be applicable following any such termination.
