

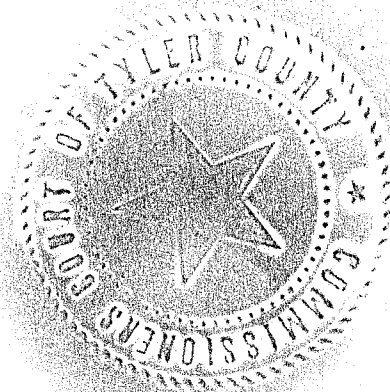
A motion was made by Judge Blanchette and seconded by Commissioner Nash that the meeting adjourn. All voted yes.

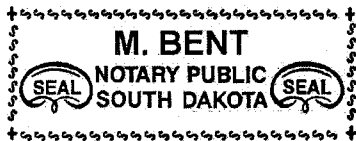

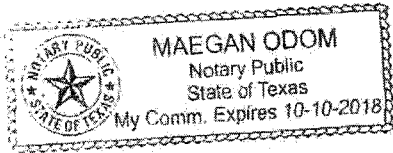

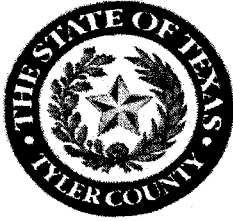
