After calling the meeting to order, Judge Blanchette invited anyone offended by the court's practice of an invocation and Pledge of Allegiance to step out in the hall and return after the conclusion of the pledge. The invocation was delivered by David Luther, Deacon at Our Lady of the Pines Catholic Church. Commissioner Nash then led in the Pledge of Allegiance to the American flag.

Public Comments: Melissa Riley, representative of Riley Funeral Home, addressed the court concerning indigent funerals. She stated in the past the county had dug the graves, but had recently had a problem with this assistance. Judge Blanchette responded the court had discussed this in the previous workshop. He will be in contact with the court's attorney and will be considering a policy to also include removals and cremation.

A motion was made by Commissioner Nash and seconded by Commissioner Sturrock to receive the minutes of both December 9<sup>th</sup> at 11:00 a.m. and 11:10 a.m. meetings. All voted yes and none no.

**Commissioner Nash** made a motion to receive the monthly reports from the **Juvenile and Adult Probation Departments, District Clerk, County Auditor, County Treasurer, County Extension and Justice of the Peace, Pct. 1. Commissioner Sturrock** seconded the motion. All voted yes and none no. SEE ATTACHED

**Budget amendments/line item transfers**, were not presented by the County Auditor.

**Commissioner Marshall** motioned to purchase a filing cabinet system to hold human resource/personnel records for the **County Treasurer's office**. The cost is approximately \$3500.00. The motion was seconded by **Commissioner Hudson**. The purchase will be paid out of the County Records Management fund. All voted yes and none no.

A motion was made by **Commissioner Sturrock** to approve a change in the **County Employee Handbook** dated August 2018, Part 3 "Benefits" Item #4, Page 22 from 25-year term to 24-year term for Retiree Healthcare Cost; also, to change to employee/official. The motion was seconded by **Commissioner Marshall**. All voted yes and none no. SEE ATTACHED

Kay Timme explained complete probable cost estimate had been received on October 24<sup>th</sup>, with all cost combined being the required and optional work. November 12<sup>th</sup> received a revised probable cost estimate, but could not tell which of the cost were optional and which were required. Again, on November 14<sup>th</sup> received invoice with cost in two columns, but changes were

confusing. November 25<sup>th</sup> received a revised invoice indicating the amount already paid on the initial contract, but still the work was not clearly divided. A revised probable cost estimate was received January 2<sup>nd</sup> that was finally in two documents showing the split of the required work vs the optional work, as requested. She is continuing to study the numbers and tract the changed. **Commissioner Sturrock** motioned to approve payment of the November revised invoices from **LaBiche Architectural Inc.** for the **courthouse remediation/rehabilitation project**. The November **invoices** are to be paid out of the courthouse remediation fund. The County Auditor will present a line-item transfer to break out the portions and identify in a line item amendment on a future agenda. **Commissioner Marshall** seconded the motion. Commissioner Sturrock stated the focus should be on the required work at this time and not the optional items. He further stated that “we are not going out for bidding on construction of the optional work”. He did not remember ever agreeing to the optional work. Judge Blanchette recalled they were strongly encouraged, by THC, to look at the totality of the work in order to minimize total cost. He replied to questions from Commissioners Marshall and Hudson: the cost was for plans and specifications looking at the scope of work in its entirety making the building totally useful. Kay Timme explained the schematic design and design development had been billed in November for \$34,000. The December bill is for the construction documents to which are 75% complete and THC also must approve. All voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Sturrock** to pay **LaBiche Architectural Inc.** for the December invoice: \$10,926.52 optional work plus \$31,098.60 required work, with the required 25%. **Commissioner Nash** seconded the motion. He then added, “we want to keep the two projects separate and as we go along and when we get to a point to be able to say no we do not want to do this on the optional projects; we don’t have the money”. Commissioner Sturrock stated there will be another invoice for the remainder. He wants to stop and take a look at the optional projects once the court receives the construction documents. All voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Nash** and seconded by **Commissioner Sturrock** to award the bid to Affordable AC Installation Services for a **maintenance agreement for air conditioners in county owned buildings**. The agreement includes a discount if they get the repair jobs. The fee is \$3500.00. The county maintenance department will change the filters. All voted yes and none no.

**Judge Blanchette** motioned to table consideration of a **county policy regarding indigent burials and dispositions**, for further study, with Melissa Riley’s comments, to capture all the requirements plus what the county may need to do. The motion was seconded by **Commissioner Marshall**. All voted yes and none no.

Sheriff Weatherford informed the court that his department would be taking over all the **bailiff duties and responsibilities**. He is responsible for courthouse security. By statute, Constables are responsible for Justice of Peace Court, but sheriff will assist. Commissioner Sturrock inquired about judges requesting their own bailiff, would this come out of their account. Sheriff cited LGC, Sec. 291.003 states the sheriff had the control of security in the courthouse; considering the liability issues would make it easier. Commissioner Nash inquired how this would affect the daily courthouse security. The sheriff answered there would be no change in daily services. The County Auditor questioned as to who would be preparing the payroll, for example with District Court. Sheriff Weatherford stated the sheriff’s office would be submitting the court bailiff’s time through his department system with notations whether it was bailiff duties or courthouse security duties. Judge Blanchette clarified that all bailiff services would be handled through the Sheriff’s office. The County Judge’s office will notify the Sheriff’s office when a bailiff is needed for county court and when court is cancelled.

Judge’s Report- Courthouse Remediation Update: Kay Timme reported she continues to analyze every number and get exact information.

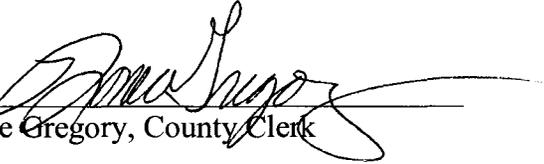
Executive Session was not held.

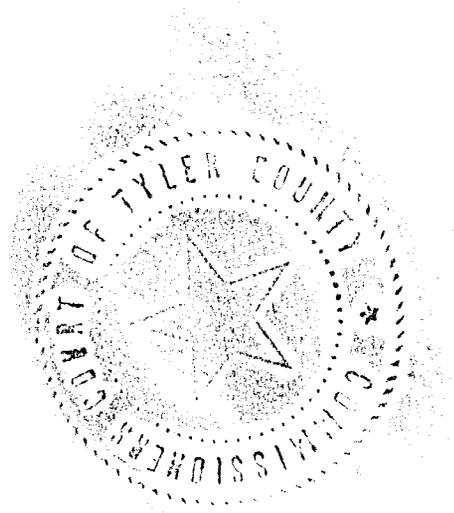
A motion was made by Commissioner Nash and seconded by Commissioner Marshall the meeting adjourn. All voted yes.

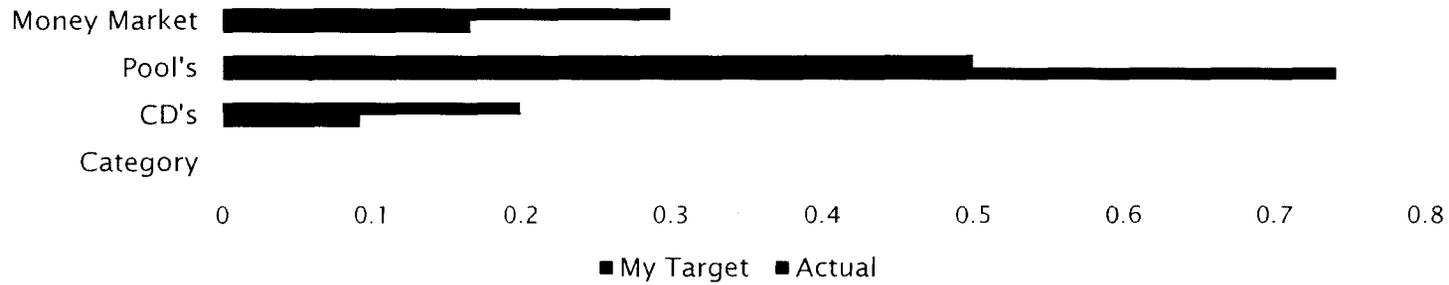

## TYLER COUNTY POLICY ON POLITICAL ACTIVITY

Employees of Tyler County shall have the right to support candidates of their choice and to engage in political activity during their personal time.

### Political Activity

Employees of Tyler County shall not:

- A. Use their official authority or influence to interfere with or affect the result of any election or nomination for office;
- B. Directly or indirectly coerce, attempt to coerce, command or advise another person to pay, lend or contribute anything of value to a party, committee, organization, agency or person for a political reason; or
- C. Be a candidate for elective office in a partisan election without taking a leave of absence, unless the incumbent of that office does not seek re-election. For definition purposes, an elected official, serving in office, is not considered an employee for the purpose of this specific provision.
- D. Use any equipment, property, or material owned by the County for political activity or engage in political activity while on duty for the county is prohibited.

## Part 3

### BENEFITS AND LEAVE

#### TYLER COUNTY POLICY ON GROUP MEDICAL AND LIFE INSURANCE

##### Eligibility

1. All regular full-time employees of the County shall be eligible for coverage under the group hospitalization program provided by the county the completion of 60 days of employment. Life Insurance will begin 6 months after the date of hire.
2. The county shall pay the premium for coverage of eligible employees.

##### Benefits

1. The benefits for this program shall be in accordance with the provisions of the master contract.

## Tyler County Indigent Cremation Policy

**WHEREAS**, in accordance with Texas Health and Safety Code § 694.002 and §711.002 and any and all other applicable Codes, Tyler County is obligated to dispose of the bodies of deceased paupers in Tyler County; and

**WHEREAS**, Tyler County Commissioners' Court has the right to adopt policies and rules to implement this statutory obligation; and

**WHEREAS**, pursuant to the said Texas Health and Safety Code §694.002, Tyler County Commissioners' Court has decided that Tyler County will pay for disposition of deceased paupers in Tyler County, in accordance with the rules adopted herein; and

**THEREFORE**, IT IS ORDERED by the County Commissioners' Court of Tyler County, Texas:

1. The findings and recitals in the preamble of this Order are hereby found and determined to be true and correct and are hereby approved and adopted.
2. A person whose death occurs in this County may be certified as a Pauper eligible for disposition to be paid by Tyler County.
3. A person shall be determined to be a pauper, for purposes of this Order, premised on lack of income or property sufficient to pay for disposition of the body.
4. Such disposition shall be by cremation.
5. The remains shall be deposited in a designated area of \_\_\_\_\_ Cemetery or released to the next of kin;
6. Policies on Funeral Home Responsibilities, Cremation, and County Responsibilities are hereby approved and attached and incorporated into this Order.

**Llano County Indigent Cremation Responsibilities:**

**Funeral Home Responsibility**

**General:**

1. Pick up and hold
2. Screen for ability to pay or to apply for County Payment
3. Process all paperwork to include that necessary according to law and as necessary to determine eligibility for Indigent Cremation
  - a. File all required documents
  - b. Request all information necessary to determine whether the person meets County Indigent Cremation Policy criteria. Information may be gathered on Llano County Application for Indigent Cremation or existing Funeral Home form so long as substantially same information is included.
4. Fax completed application to County Judge for Approval of Cremation to be paid by County
5. Upon receipt of approval, file death certificate and notify Social Security Administration
6. Invoice County for approved services in the amount of : \_\_\_\_\_
7. Accept County program funds as payment in full
  - a. DO NOT waiver from Indigent Cremation policies approved by the County
  - b. DO NOT accept funds from next of kin to provide additional services or to supplement county approved services
  - c. Reimburse the county in the event unforeseen funds are received from any other source.

**County Responsibility for Cremation:**

The County will assist with cremations in accordance with the prevailing law upon approval from the County Judge's Office. The County will not provide any other type of service, viewing, burial or amenities for deceased indigents. No additional amenities will be permitted independently by the next of kin or via supplemental payment to the funeral home.

County approved cremation package consists of:

- Pickup and hold
- Cremation
- Container
- Disposition of remains as arranged by the funeral home when no responsible party can be identified

## TYLER COUNTY APPLICATION FOR INDIGENT CREMATION

The Tyler County Policy for the Cremation of Paupers provides as follows:

"A person whose death occurs in this County may be certified as a pauper eligible for cremation by the County under this policy if the County Judge determines, after reasonable investigation that the estate of the decedent does not have any resources that may be used to pay for interment; and the decedent's next of kin cannot pay for interment because they do not have resources that may be used to pay for interment; or their identities or whereabouts are unknown."

Pursuant to the Texas Health and Safety Code, §711.002(a), the following persons, in the priority listed, have the duty of disposition for the decedent's remains and are liable for the cost of interment.

1. The person designated in a written instrument signed by the decedent,
2. The decedent's surviving spouse,
3. Any one of the decedent's surviving adult children,
4. Either one of the decedent's surviving parents,
5. Any one of the decedent's surviving adult siblings,
6. Any adult person in the next degree of kinship in the order named by law to inherit the estate of the decedent

The information requested in the following form is necessary to determine eligibility under the County policy. It is not intended to cause embarrassment or to pry needlessly into your private affairs. Please be as detailed as possible in answering the questions. ## TYLER COUNTY POLICY ON POLITICAL ACTIVITY

Employees of Tyler County shall have the right to support candidates of their choice and to engage in political activity during their personal time.

### Political Activity

Employees of Tyler County shall not:

- A. Use their official authority or influence to interfere with or affect the result of any election or nomination for office;
- B. Directly or indirectly coerce, attempt to coerce, command or advise another person to pay, lend or contribute anything of value to a party, committee, organization, agency or person for a political reason; or
- C. Be a candidate for elective office in a partisan election without taking a leave of absence, unless the incumbent of that office does not seek re-election. For definition purposes, an elected official, serving in office, is not considered an employee for the purpose of this specific provision.
- D. Use any equipment, property, or material owned by the County for political activity or engage in political activity while on duty for the county is prohibited.

## Part 3

### BENEFITS AND LEAVE

#### TYLER COUNTY POLICY ON GROUP MEDICAL AND LIFE INSURANCE

##### Eligibility

1. All regular full-time employees of the County shall be eligible for coverage under the group hospitalization program provided by the county the completion of 60 days of employment. Life Insurance- will begin 6 months after the date of hire.
2. The county shall pay the premium for coverage of eligible employees.

##### Benefits

1. The benefits for this program shall be in accordance with the provisions of the master contract.
2. A copy of the master contract shall be kept in the County Auditor's office, and may be reviewed by employees during normal working hours.
3. When an employee retires from the county at age (62) sixty-two, and has (8) continuous (unbroken) years of service to Tyler County, Tyler County will pay 100% of the health insurance premium until they reach the age of sixty-five (65) and four (4) months.

For the employee who retires before the age of sixty-two (62), the employee has twenty-five (25) years of continuous (unbroken) service with Tyler County and meets the seventy-five (75) points rule, the County will pay eighty (80%) of the health insurance premium and the other twenty (20%) will be paid by the Retiree.
