A motion was made by **Commissioner Sturrock** and seconded by **Commissioner Blacksher** to authorize the County Judge to execute a professional services agreement with [Washburn & Company Land Services](#) to provide residential surveys for the HUD funded Community Development Block Grant **Disaster Relief (CDBG-DR) Buyout Program**, upon review by legal counsel, Eric Magee. A motion was made by **Commissioner Sturrock** and seconded by **Commissioner Blacksher** to authorize the County Judge to execute a professional services agreement with **Tyler County Title** to provide title commitments, formal title closings and transfers of title for the HUD funded Community Development Block [Grant Disaster Relief \(CDBG-DR\) Buyout Program](#), upon review by legal counsel, Eric Magee. All voted yes and none no. SEE ATTACHED
