THE STATE OF TEXAS ON THIS THE 28th day of December, 2021 the Commissioners' Court in and for Tyler County, Texas convened in a Special Meeting at the Commissioners Courtroom in Woodville, Texas, the following members of the Court present, to wit:

The following were absent: Judge Blanchette and Commissioner Marshall thereby constituting a quorum. In addition to the above were:

Commissioner Sturrock opened the meeting and presided in the absence of Judge Blanchette and Judge Pro-Tem, Commissioner Marshall. Commissioner Blacksher delivered the invocation and then led the Pledge of Allegiance to the American Flag.

PUBLIC COMMENTS: None

Budget Amendments were not presented

Commissioner Blacksher made a motion to approve paying the **county bills**. **Commissioner Hudson** seconded the motion. Commissioners Blacksher, Sturrock, and Hudson voted yes and none no.

Commissioner Sturrock motioned to adopt the Order to Conform Election Precincts following the redistricting of the Commissioners Court Precincts Pursuant to Chapter 42, Texas Election Code, and Any Resulting Changes That May Have an Impact Upon the Justice of the Peace/Constable Precincts.

Commissioner Blacksher seconded the motion. The affected voting precincts are #1, #2, #3, #4, #16, #17 and #18. Commissioners Blacksher, Sturrock, and Hudson voted yes and none no. SEE ATTACHED ORDER

A motion was made by **Commissioner Sturrock** to approve a lease to purchase a 2022 Komatsu GD655-7 Motor Grader through Source Well from Waukesha-Pearce Industries, LLC to be financed with First National Bank Wichita Falls, Texas for Precinct 2. The lease will be approximately \$31,000 a year for five years. **Commissioner Hudson** seconded the motion. Commissioners Blacksher, Sturrock, and Hudson voted yes and none no. SEE ATTACHMENT

A motion was made by **Commissioner Sturrock** and seconded by **Commissioner Blacksher** to consider approving or disapproving any or all of the required conditions for Lakeland Ranch Section One Subdivision. Commissioner Blacksher read the five conditions: Conditions 1-4 have been satisfied. Condition 5 (financial guarantee) remains outstanding. It was a consensus of the court to approve Conditions 1 through 4, having been satisfied and to disapprove Condition 5 until the condition has been met and will be brought back for consideration. Commissioners Blacksher, Sturrock, and Hudson voted yes and none no. SEE ATTACHMENT
