Texas Government Code §2206.151-157 requires public and private entities with eminent domain authority to report specific information to the Comptroller for posting in an online eminent domain database at <http://coedd.comptroller.texas.gov> **Entities must submit an Eminent Domain Report with required information in a form and in the manner prescribed by the Comptroller not later than February 1 of each year in accordance with Government Code §2206.154.**

Our records show that Tyler County filed an Eminent Domain Report for 2020, but has not yet filed the report due for 2021. This communication is the Comptroller's first written notice, by virtue of Government Code §2206.155, and is intended to inform you that:

1. Your entity did not timely submit an Eminent Domain Report as required for 2021 and is in violation of Government Code §2206.154.
2. If your entity fails to submit the required Eminent Domain Report in accordance with Government Code §2206.154, to the Comptroller's office within 30 days of this initial notice of non-compliance, your entity will be liable to the State of Texas for an initial \$1,000 civil penalty.

Note that an entity that does not report the required Eminent Domain report, in accordance with Government Code §2206.154, may be subject to a maximum penalty of \$2,000 for each report year.
