A motion was made by **Commissioner Hudson** to open bids for **petroleum products** for Tyler

Commissioner Blacksher seconded the motion. All commissioners voted yes and none no. Bids
were received from Billy Williams and CAT Excavation Construction

Commissioner Marshall motioned to discuss awarding a bid for a grant administrator for the Colmesneil ISD drainage project. **Commissioner Sturrock** seconded the motion. All commissioners voted yes and none no. The County Auditor stated only one bid had been received- Lankford Community Management Services. She read the cost as stated on the bid. A motion was made by **Commissioner Sturrock** to award the bid for **FEMA DR-4485 Grant Administrator** of the **drainage project for Colmesneil ISD** to Lankford. The motion was seconded **Commissioner Blacksher**. All commissioners voted yes and none no.

A motion was made by **Commissioner Sturrock** to amend the artwork/wall decorations section of the **Tyler County Courthouse Appearance Guidelines** to include portraits of sitting elected officials to be allowed in public areas and offices. **Commissioner Blacksher** seconded the motion. COMMENTS BY COURT MEMBERS PERTAINING to MATTERS of COUNTY GOVERNMENT: Commissioner Sturrock reported the local Tyler County Historical Commission and Mr. LaBiche has contacted the state historical commission to get authorization for blinds. Commissioner Blacksher questioned the specifics on setting up an auction for items to sale. It was decided June 4th through the 15th.

Commissioner Sturrock motioned to award Gardner Oil the bid for **petroleum products**. **Commissioner Blacksher** seconded the motion. All commissioners voted yes and none no.

Commissioner Marshall motioned to award all bids for **road material**, due to locations of the precincts. **Commissioner Sturrock** seconded the motion. All commissioners voted yes and none no.

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Blacksher** to award all bids **Hauling for Tyler County**, due to locations of the precincts. All commissioners voted yes and none no.
