After calling the meeting to order, Judge Blanchette stated "it is the practice of the court to exercise an invocation followed by the Pledge of Allegiance to the flag. Anyone who may not be comfortable with the practice may wish to step out into the hall and rejoin once the portion of the agenda begins with public comments." Commissioner Blacksher delivered the invocation and then led the Pledge of Allegiance to the American Flag.

**PUBLIC COMMENTS: Terry Allen-** addressed the need for public transportation. She reported that DETCOG would reimburse the cost of anyone 60 and over riding the van. There would need to be an investment from the county. The transport van would be registered in the name of the county.

**Sal Baldovinos** – read an editorial quote of a citizen and made his opposition known that he felt it was racist and anti-naturalized citizen veterans. He requested the court take into consideration the access to the courtroom being given to this person.

#### CONSIDER/APPROVE/INFORMATION:

The County Auditor presented a report showing the amount of fund balance being used to balance the budgets from 2015 forward to keep from raising the tax rate. The most recent being \$728,000. The draft budget includes a \$3000 salary increase and increases to insurance. A rate of \$.5619 for general fund would only require \$82,000 of the fund balance.

A motion was made by Commissioner Marshall and seconded by Commissioner Hudson to set the proposed tax rate for the County General Fund at \$ .5619. The record vote was Judge Blanchette voting no; Commissioner Blacksher voting no, Commissioner Sturrock voting yes, Commissioner Marshall voting yes and Commissioner Hudson voted yes.

A motion was made by Commissioner Marshall and seconded by Commissioner Hudson to set the proposed tax rate for the County Farm to Market Flood Control Fund at \$ .2178. The record vote was Judge Blanchette voting no; Commissioner Blacksher voting no, Commissioner Sturrock voting yes, Commissioner Marshall voting yes and Commissioner Hudson voted yes.

A motion was made by Commissioner Sturrock and seconded by Commissioner Marshall to set the proposed tax rate for the Tyler County Hospital Fund at \$ .1800 to cover the increases in indigent healthcare. The record vote was Judge Blanchette voting yes; Commissioner Blacksher voting yes, Commissioner Sturrock voting yes, Commissioner Marshall voting yes and Commissioner Hudson voted yes.

Commissioner Marshall motioned to amend the agenda item to include setting a public hearing date and time on the proposed tax rate for the Tyler County Hospital. Commissioner Sturrock seconded the motion. Commissioner Marshall motioned to set the date and time of September 6<sup>th</sup> at 9:00 a.m. for public hearings on the proposed tax rates: General Fund and Farm to Market Flood Control Fund and Tyler County Hospital. Commissioner Sturrock seconded the motion. Commissioners Blacksher, Sturrock, Marshall and Hudson voted yes and none no.

## COMMENTS BY COURT MEMBERS PERTAINING TO MATTERS OF COUNTY GOVERNMENT: none
