Grantor hereby waives personal and written notice of the said Commissioner's Court action with respect to this Dedication. This dedication is subject to all

matters of record. This dedication does not waive any claims that may arise from any demolition, construction, maintenance, and repair work on the road right of way, including the bridge across Kimball Creek, in the event such work is the direct and proximate cause of damage by flooding, erosion or other like damage to property of Grantor.


