### ORDER ADOPTING 2022 TAX RATE

BE IT ORDERED by the Commissioners Court of Tyler County, Texas that:

The Commissioners Court of Tyler County, Texas does hereby adopt the tax rate on \$100 valuation for Tyler County for the tax year 2022 as follows:

- Tax Rate of \$0.5619 for Tyler County General Fund
- Tax Rate of \$0.2178 for Farm to Market Flood Control Fund
- Tax Rate of \$0.1800 for Tyler County Hospital
  
- Total Tax Rate: \$0.9597

THESE TAX RATES WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE

"THE TAX RATE FOR GENERAL FUND WILL EFFECTIVELY BE RAISED BY 11.9 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$60.00"

"THE TAX RATE FOR COUNTY FARM TO MARKET FLOOD CONTROL FUND WILL EFFECTIVELY BE RAISED BY 16.9 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$31.60"

"THE TAX RATE FOR TYLER COUNTY HOSPITAL WILL EFFECTIVELY BE RAISED BY 17% PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$26.90"
