After calling the meeting to order, Judge Powers stated "it is the practice of the court to exercise an invocation followed by the Pledge of Allegiance to the flag. Commissioner Blacksher delivered the invocation and then led the Pledge of Allegiance to the American Flag.

A motion was made by **Commissioner Hudson** to leave consideration of an Interlocal Agreement between Tyler County Precinct #2 and the City of Chester as tabled. **Commissioner Blacksher** seconded the motioned. Commissioner Blacksher and Commissioner Hudson voted yes and none no.

A motion was made by Commissioner Hudson and seconded by Commissioner Blacksher to receive the minutes from August 14th and 28th, 2023. All commissioners voted yes and none no.

RESOLUTION/PROCLAMATIONS/ORDERS/RECOGNITIONS: Judge Powers read a 911 Proclamation while standing in honor and memory of the attacks on America. Judge Powers led a moment of silence and said a prayer.

A motion was made by **Commissioner Blacksher** and seconded by **Commissioner Hughes** to approve the **Accounts Payable/County Bills**. All commissioners voted yes and none no. SEE ATTACHED

Commissioners Court September 5, 2023

Judge Powers read Ken Jobe's resignation as Emergency Management Coordinator for the past seven years. The court presented him with a plaque and expressions of gratitude. A motion was made by **Commissioner Blacksher** and seconded be **Commissioner Hudson** to accept Ken Jobe's resignation as the **Emergency Management Coordinator** for Tyler County. Judge Powers announced Trisher Ford as the interim coordinator. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Hughes** and seconded be **Commissioner Blacksher** to reappoint Sondra Williams to the Board of Trustees representing Tyler County to the **Burke Center** for another two-year term (September 1, 2023 – August 31, 2025). All commissioners voted yes and none no.

Commissioner Blacksher motioned to ratify the subscription renewal for **Carahsoft Technology Corp.**, a cell phone forensic software for the **sheriff's department. Commissioner Hudson** seconded the motion. All Commissioners voted yes and none no. SEE ATTACHED

Commissioner Blacksher motioned to purchase AG supplies for the **fairgrounds** such as water tanks, hoses, etc. for EOC to enable the county to house evacuated animals at the fairgrounds using account 48-000-43200 **Emergency Disaster Relief Basic Operations.** These supplies would be kept at the EOC when not in use. The motion was seconded by **Commissioner Hughes.** Ken Jobe explained due to the recent fires, this service was almost opened. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Hudson** and seconded by **Commissioner Blacksher** to purchase **HAM radio equipment** for the EOC to enable the County to send and receive emails (resource request) via HAM radio, using account 48-000-43200 Emergency Disaster Relief Basic Operations, as presented by Ken Jobe. All commissioners voted yes and none no. SEE ATTACHED

Commissioner Blacksher motioned to approve the request for **variance** from the requirements of Appendix M of the Tyler County Subdivision Regulations, which states that single-family residences are presumed to generate 10 one-way trips per day. The motion was seconded by **Commissioner Hudson**. Commissioner Blacksher expounded on the review by Jed Morris, engineer in reference to the request for **Lakeland Ranch, Section Nine**. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Blacksher** and seconded by **Commissioner Hudson** to grant **conditional approval of Lakeland Ranch section nine(9)**, upon recommendation by Jed Morris, engineer. Commissioner Blacksher read the letter of recommendation aloud. All commissioners voted yes and none no. SEE ATTACHED

COMMENTS BY COURT MEMBERS PERTAINING TO MATTERS OF COUNTY GOVERNMENT:

Commissioner Blacksher- request to add Senior Nutrition Program to the monthly report section of the agenda. He reported over 1079 meals were served in one month. There is attendance from "all over the county". Received \$2221.00 in donations.

Judge Powers- expressed appreciation to first responders and forest services during the fires in the county. He stated there were over 300 people there ready to fight fire. He expressed appreciation to Commissioners Court September 5, 2023

Congressman Babin and Representative Ashby for the constant communication. Sheriff's department coordinated evacuations smoothly.

Commissioner Hughes- stated watching the planes scooping and dropping water was very impressive. **Ken Jobe-** announced 207.4 acres had burned during the recent fires. He reported a total of 11 air assets rotating fighting the fire in the county.

EXECUTIVE SESSION: not held

A motion was made by Commissioner Blacksher and seconded Commissioner Hughes that the meeting be adjourned. All commissioners voted yes and none voted no.
