THE PROPOSED TERM OF THE AGREEMENT SHALL BE: One (1) Year with annual renewal option as set forth below.

DESCRIPTION OF APPLICATION:

ICrimeFighter Enterprise: A mobile and web-based evidence gathering application that replaces a video camera, digital camera, audio recorder, and field notebook. ICrimeFighter Enterprise securely stores all evidence data in a secure cloud that is web accessible.

LICENSE FEE and PAYMENTS:

Client agrees to purchase site license with the annual licensing fee of \$ 20,000 for a 1-year annual term. ICrimeFighter Enterprise will invoice the client on the date of this order, net payable in (30) days from the date of the order.

The paid License fee provides the Client to be eligible for all product enhancements and feature updates done to At-Scene. Annual license fee includes secure cloud storage, support, updates and training.

ICrimeFighter Enterprise will invoice the additional licenses payable within thirty (30) days from the date of the order..

Yearly increase of service at 5%

Data and Security:

All data uploaded by Tyler County to the ICrimeFighter Enterprise solution hosted by AWS is property of Tyler County.

ICrimeFighter Enterprise securely stores all evidence data in a secure cloud that is web accessible. ICrimeFighter is hosted on the AWS GovCloud and meets all CJIS and FIPS requirements.

ICrimeFighter Enterprise will keep the ICrimeFighter Enterprise web application up to date with all CJIS and FIPS requirements and changes.

Client and ICrimeFighter Enterprise shall use reasonable efforts and, in any event, efforts that are no less than those used to protect its own confidential information to protect data from disclosure and to ensure that confidential information is accessible only to its employees or agents who require access to it for the purpose of this Agreement.

Terms and Conditions:

Client agrees to provide 60 days written notice of termination. ICrimeFighter Enterprise agrees to provide 120 days written notice, providing the client enough time to move their stored data. In the event ICrimeFighter Enterprise decides to cancel this agreement and the 120-day notice is beyond the current paid agreement term, the Client is not responsible for paying for any additional months beyond the agreement term in effect at that time.

Renewal:

This agreement may be renewed equal in duration to the initial term through a "Renewal Invoice" net payable within 30 days at the end of each term. If changes are needed for the Renewal, client and ICrimeFighter Enterprise agree to provide 60-day written notice of those changes before the Renewal.
