After calling the meeting to order, Judge Powers invited anyone offended by the court's practice of an invocation and Pledge of Allegiance to step out in the hall and return after the conclusion of the pledge. Judge Powers led in the Pledge of Allegiance to the American flag and delivered the invocation.

PUBLIC COMMENTS: Chief Scott Yosko- Support relief route as proposed by Greg Adams and Steve Pittman. Many major problems with the routes proposed by TXDot, according to his many years of experience directing traffic due to hurricane evacuations.

Robert Smith- Validity of car number of projections, 28,500 cars per day, by 2027. He felt the traffic projections were invalid. TXDot routes would affect the economic growth of Woodville.

TABLED ITEMS FROM PREVIOUS MEETING: Commissioner Blacksher motioned to remove with no action – Additional FEMA module being added to our IWORQ software.

Commissioner Marshall seconded the motion. All commissioners voted yes and none no.

Colmesneil Relief Route to the **Texas Department of Transportation**. All commissioners voted yes and none no.

A motion was made by **Commissioner Hughes** to adopt the **Tyler County Commissioners' suggested route proposal for US Highway 69 Woodville – Colmesneil Relief Route** to the **Texas Department of Transportation**. The motion was seconded by **Commissioner Marshall**. Judge and Commissioner Marshall thanked Greg Adams and Steve Pittman for their work on the project. All commissioners voted yes and none no. Judge Powers read the resolution. **Commissioner Marshall** motioned to adopt the resolution supporting Tyler County Commissioners' suggested route proposal for **US Highway 69 Woodville – Colmesneil Relief Route** to the **Texas Department of Transportation**. **Commissioner Hudson** seconded the motion. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Blacksher** and seconded by **Commissioner Marshall** to return to support for **records management software** from **Southern Software** in the **Criminal District Attorney's** office. All commissioners voted yes and none no. SEE ATTACHED This allows the renewal of use of software from Southern Software.

Commissioner Blacksher motioned to reject all **bids for material hauling**. **Commissioner Marshall** seconded the motion. All commissioners voted yes and none no.

A motion was made by **Commissioner Blacksher** to re-advertise for **bids for material hauling** to commissioner precincts #1, #2, #3, and #4. **Commissioner Hughes** seconded the motion. All commissioners voted yes and none no.

COMMENTS BY COURT MEMBERS PERTAINING TO MATTERS OF COUNTY GOVERNMENT:

Judge Powers- commented on a meeting including Mandy Risinger. TXDot stated they did not own enough property along the rail bed for a relief route proposed many years ago. Research shows that TXDot land ownership was stated incorrectly by TXDot which is a waste of tax dollar money already spent

Executive Session: Not held


Formal action following Executive Session: none
