After calling the meeting to order, Judge Powers stated “it is the practice of the court to exercise an invocation followed by the Pledge of Allegiance to the flag.” “Anyone who may not be comfortable with the practice may wish to mute their phone/computer (for those attending by teleconference) or step out into the hall and rejoin once the portion of the agenda begins with public comments.” Commissioner Marshall led the Pledge of Allegiance to the American Flag. Sheriff Weatherford delivered the invocation.

**CONSENT AGENDA:**

A motion was made by Commissioner Blacksher and seconded by Commissioner Marshall to receive the minutes of November 20, 2023. All commissioners voted yes and none no.

**Commissioner Hudson** motioned to receive the **monthly reports** from the Juvenile Probation Department and Adult Probation Department, County Auditor, County Clerk, County Extension and Justice of the Peace, Pct. 1. **Commissioner Hughes** seconded the motion. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Hudson** to approve the **Budget Amendment/Line-Item Transfers**. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Blacksher** and seconded by **Commissioner Marshall** to approve the **Accounts Payable/County Bills** as presented by the County Auditor. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Hughes** to approve the **County Treasurer's monthly report**. All commissioners voted yes and none no. SEE ATTACHED

**Commissioner Hughes** motioned to table ratification of deputation of Chantel James in the **County Clerk's office**. **Commissioner Marshall** seconded the motion. All commissioners voted yes and none no.

**Commissioner Blacksher** motioned to table introduction of new deputy clerk, Chrystal Farris in the **District Clerk's office**. **Commissioner Hughes** seconded the motion. All commissioners voted yes and none no.

**Commissioner Hudson** motioned to approve the contract for **preservation of probate records** from 1800s through 1950 and pre-preservation of records from 1951 to June 1964. **Commissioner Marshall** seconded the motion. All commissioners voted yes and none no. SEE ATTACHED

**Commissioner Hudson** motioned to advertise for bids for a 2024 Chevrolet for **Precinct #4 road and bridge department**. The motion was seconded by **Commissioner Blacksher**. All commissioners voted yes and none voted no.

A motion was made by **Commissioner Marshall** to renew the **airport hangar (#4) Lease Agreement** with George "Jim" Huckins, Jr. The motion was seconded by **Commissioner Hughes**. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Blacksher** to accept the donation (\$240) from Kelly Barnes, representing Tyler County Booster to be applied to the **Veterans Service department**. The motion was seconded by **Commissioner Hughes**. All commissioners voted yes and none no. SEE ATTACHED

**Commissioner Blacksher** motioned to ratify change order #5 for **Tyler County Phase II renovations**. The motion was seconded by **Commissioner Hughes**. All commissioners voted yes and none no. SEE ATTACHED

Sheriff Weatherford explained that due to staff shortages some of his employees had not been able to take all their time off. He requested payoff of the time down to the amount that can be carried over, using funds in his budget. Judge Powers suggested a workshop for next year to address a policy. **Commissioner Hughes** motioned to allow departments to do **vacation and compensation time payouts** of time for employees, so that they do not lose the time that cannot be carried over, before the end of the year. **Commissioner Blacksher** seconded the motion. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Blacksher** to approve the annual **i3Verticals (Net Data) and RVI Imaging software maintenance** for the County Clerk and JP offices. **Commissioner Hughes** seconded the motion. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Blacksher** and seconded by **Commissioner Hughes** to re-appoint Ethel Rogers, Betty Whitworth, and Michael Marshall to the **Tyler County Hospital Board of Managers** for the term beginning January 1, 2024. All commissioners voted yes with exception to Commissioner Marshall abstaining, and none no. SEE ATTACHED

**Commissioner Marshall** motioned to reappoint Glen Kenny, L.R. Johnson and Ronald Willmon to the Emergency Services District (ESD#5) for a two-year term beginning January 1, 2024 and expiring December 31, 2025. **Commissioner Hudson** seconded the motion. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Blacksher** and seconded by **Commissioner Hughes** to authorize County Judge, Milton Powers to execute the **TxDOT Local Government Assistance Program Agreement**. All commissioners voted yes and none no. SEE ATTACHED

Frankie Rogers presented the need of assistance for **Tyler County Veterans**; made the court aware that one pharmacy on the county ended their "government contract"; some veterans are having to travel out of the county to get medications; expansion of Brookshire Bros Pharmacy and whether a permit is required. Judge Powers recommended a letter of support from commissioners court to be reviewed by attorneys for the county. A motion was made by **Commissioner Blacksher** to send a letter of a support to help veterans get their medications more conveniently, after review by attorneys for the county. **Commissioner Hudson** seconded the motion. All commissioners voted yes and none no. SEE ATTACHED

**Commissioner Hudson-** letter to TxDOT to take care of “aprons” on the highway where it meets a county road, such as “pot holes” in the state right-of-way.
