Dear Judge Powers,

Construction bids were received by the County for the referenced project on December 12, 2023. A tabulation of the bids is attached.

The Base Bid included site clearing and grading, construction of a 20,000 gallon ground storage tank, site fencing and a highway bore. An Additive Alternate was bid for a 30,000 gallon ground storage tank in lieu of a 20,000 gallon ground storage tank.

One bid was received from SETEX Construction Corp. Their total Base Bid was \$397,000.00. Their total Additive Alternate Bid amount was \$20,000.00.

The amount budgeted for this work was \$129,500. Because we received only one bid and it far exceeds the construction budget, we recommend that the Tyler County SUD reject all bids. We would also request the County's authorization to modify the bid documents as necessary and rebid.

Tyler County SUD approved this recommendation at their Board meeting on December 19, 2023.

Materials only bids were received by the County for the referenced project on December 12, 2023. A tabulation of the bids is attached.

In order to maximize bidder participation, bidders were allowed to provide bids for any combination of two packages as described below:

PACKAGE 1 – PIPE AND APPURTNENCES: Materials necessary to construct 7,725 feet of waterline, plant piping and appurtenances PACKAGE 2 - PUMPS: Two vertical multi-stage booster pumps.

Bids were received from three bidders as detailed on the attachment and summarized below:

We recommend the Materials Only contract for the Base Bid PACKAGE 1 be awarded to Rural Pipe and Supply, Inc. in the amount of \$79,650.00. We recommend that Materials Only contract for Base Bid PACKAGE 2 be awarded to Pumps of Houston in the amount of \$28,240.00. The total budgeted amount for these contracts is \$148,000.00.
