We are writing to formally request that the Texas Department of Transportation (TxDOT) consider the addition of a road that is in Tyler County, Pct. 2. This road begins in Polk County, Texas but crosses into Tyler County. The length of the road is 2.17 miles. The coordinates are as follows beginning at the south end 94 36.0676506 West and 30 45.7790447 North and ending on the North side 94 36.4606991 West and 30 47.4979304 North (Longitude/Latitude). The previous commissioner of Polk County maintained it as a courtesy to Tyler County because most of the road is in Polk County. However, the newly elected Commissioner in Polk County will not continue to maintain the portion that resides in Tyler County. This road needs to be maintained properly and legally allowing the citizens to access it. Therefore, our county is requesting that this be formally added to TxDOT's list in Tyler County.

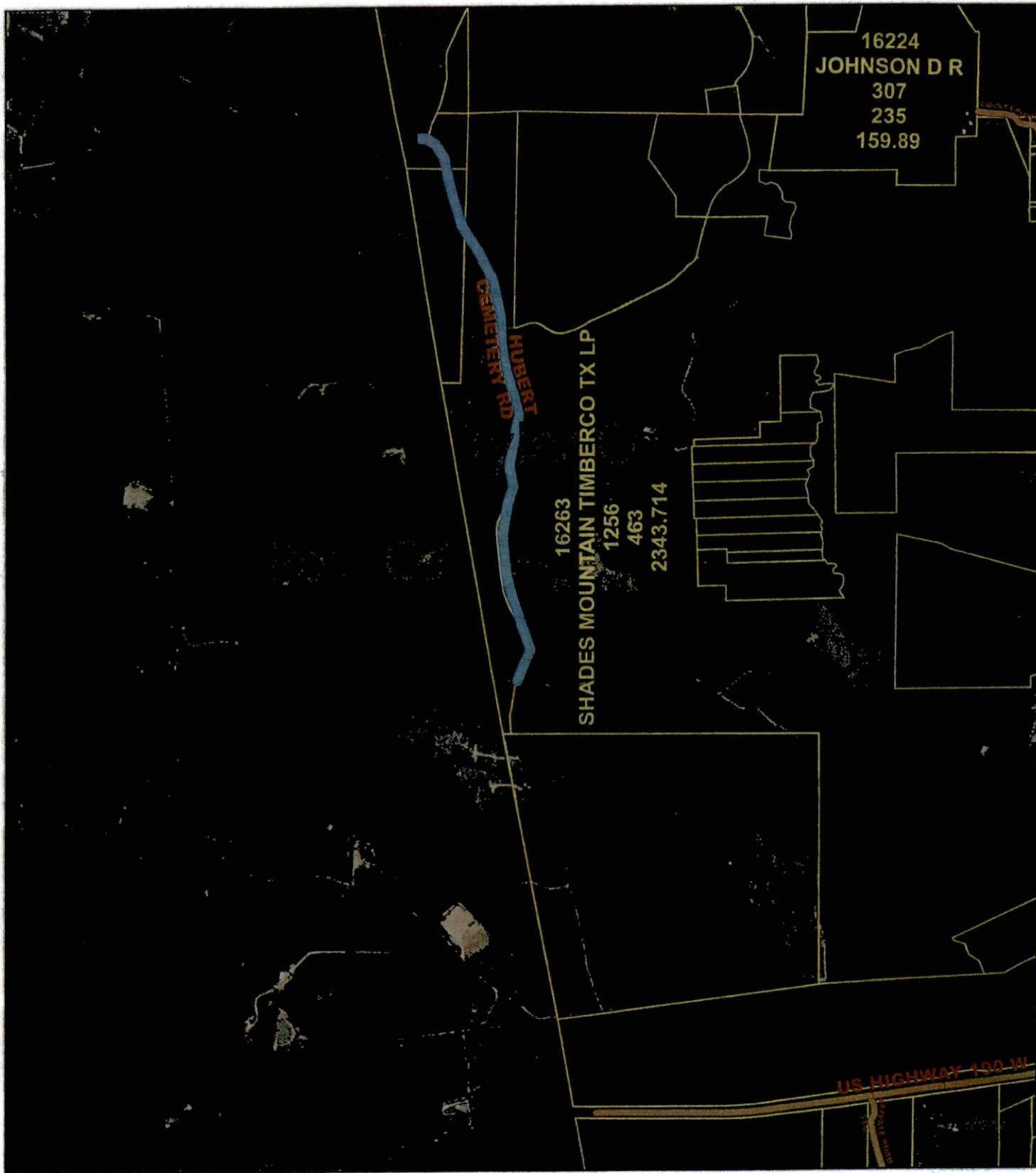
