**A RESOLUTION FO TYLERCOUNTY, TEXAS AUTHORIZING THE FILING OF A GRANT APPLICATION WITH THE DEEP EAST TE3XAS COUNCIL OF GOVERNMENTS FOR A REGIONAL SOLID WASTE GRANTS PROGRAM GRANT; AUTHORIZING MILTON POWERS TO ACT ON BEHALF OF TYLER COUNTY IN ALL MATTERS RELATED TO THE APPLICATION; PLEDGING THAT IF A GRANT IS RECEIVED TYLER COUNTY WILL COMPLY WITH THE GRANT REQUIREMENTS OF THE DEEP EAST TEXAS COUNCIL OF GOVERNMENTS, THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY AND THE STATE OF TEXAS.**

**WHEREAS**, the Deep East Texas Council of Governments is directed by the Texas Commission on Environmental Quality to administer solid waste grant funds for implementation through the COG's adopted regional solid waste management plan; and

**WHEREAS**, Tyler County in the State of Texas is qualified to apply for the grant funds under the Request for Applications.

**NOW, THEREFORE, BE IT RESOLVED BY TYLER COUNTY OF TYLER COUNTY TEXAS;**

1. That Milton Powers is authorized to request grant funding under the Deep East Texas Council of Government's Request for Application of the Regional Solid Waste Grants Program and act on behalf of Tyler County in all matters relate3d to the grant application and any subsequent grant contract and grant project that may result.
2. That if the project is funded, Tyler county will comply with the grant requirements of the Deep East Texas Council of Governments, Texas Commission on environmental Quality and the State of Texas.
3. The grant funds and any grant-funded equipment or facilities will be used only for the purposes for which they are intended under the grant.
4. That activities will comply with and support the adopted regional and local solid waste management plans adopted for the geographical area in which the activities are performed.
