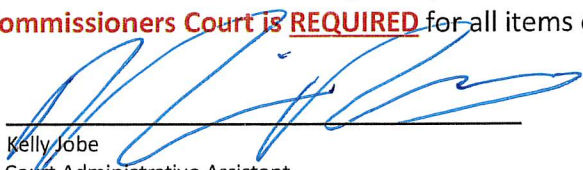

Non-Exclusive License and Services Agreement

THIS ADDENDA is entered into and executed by and between TYLER COUNTY, TEXAS ("COUNTY") with administrative offices located at Tyler County Courthouse, Woodville, Texas, and Local Government Solutions, L.P. ("VENDOR"), having its principal place of business at 2693 Hwy 77, North, Suite 2100, Waxahachie, Texas 75165:

WHEREAS, the Commissioners Court of the COUNTY has determined that it desires to amend the existing contract for data processing services to add the ability to use the Arresting Agency Portal for the office of the District Attorney; and

WHEREAS, the COUNTY is a willing participant in this Addendum and is bound by the existing Agreement with the VENDOR hereinafter referred to as Contract # LGS24-0018 and entitled Non-Exclusive License and Services Agreement (NLSA), which is on file in the Tyler County Clerks Records. The NLSA shall be the governing agreement with this and any future addendums forming the entire agreement;

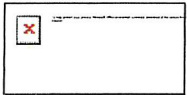
